

Negroes In Bus Boycott Hold Out For Integration

TALLAHASSEE, Fla. (AP)—Tallahassee Negroes last night publicly ignored an announcement that bus service will be resumed here and reaffirmed their determination to hold out for fully integrated seating.

No mention was made at a mass meeting of the Negro Inter Civic Council of plans announced by the Cities Transit Co. to reinstate the service suspended July 1. The company halted operations in the wake of financial losses caused by the Negro boycott. The boycott is a protest against segregated seating.

Instead, council members said they would keep on providing their own transportation by means of collection toward purchase of station wagons to serve the Negro community.

The transit company announced it will resume service over routes to be determined by a survey of potential riders. If Negroes are not willing to ride, the routes will serve white neighborhoods only, said Cities Transit Manager Charles L. Carter.

The bus company acted in a response to a request from the Tallahassee Chamber of Commerce, which plans to sponsor a ride-the-bus campaign. This city of 40,000 population has been without public transportation except for taxicabs for nearly two weeks.

Fredrick Bullock Passes Wednesday

Frederick Ernest Bullock, 80, 748 S.E. Brockway Ave., Roseburg, died July 11 in a local hospital. He was an old-time resident of Kellogg.

Born Oct. 29, 1875, in Sheffield, England, he came to the United States at the age of three and a half years. His parents settled in Nebraska and Fred lived there until 1904. He was united in marriage to Nannie George on Dec. 24, 1902. They came to Oregon, settling in Kellogg, in 1904, and lived there for 42 years, coming to Roseburg in 1946. He was a member of the First Baptist Church of Roseburg.

Surviving are: his wife, Nannie Bullock, Roseburg; two daughters, Mrs. LeRoy (Mildred) Ladd, Roseburg, and Mrs. Eldon (Elizabeth) Fisher, Kellogg; four sons: George and Milo Bullock, both of Kellogg and Dale and Merrill Bullock, both of Brookings; a sister, Mrs. Lillian Hensell, Roseburg; 16 grandchildren, and two great-grandchildren.

Funeral services will be held in The Chapel of the Roses Friday at 2 p.m. Dr. Eugene Gerlitz, of the First Baptist Church will officiate. Interment will follow in the Roseburg Memorial Gardens.

in each of Oregon's counties.

The decrease in the utility base and increase in the timber values may effect a large increase in the total county valuation.

Bowker said the utilities valuations in Douglas last year totaled about \$22,750,000, about 25 per cent of the county total of 99 million dollars.

After the new valuations are published this year, utilities may be valued only at about 18 per cent of perhaps a 100-million-dollar total county valuation.

Bowker said the whole effect won't be known for a few weeks. Valuations in the various districts in the county haven't yet been figured.

2. Hall looks for Nixon to play a big and "very vigorous" role in the campaign.

Asked how the Republicans will meet the issue of the health of the President who has suffered a heart attack and undergone a major operation in the past several months, Hall said it already has been met by "frankness and candor."

Hall said that is "the complete answer" and "nothing has been kept from the American people."

As a result, the national chairman said, there is no indication that any one other than Nixon may be placed in nomination at the GOP convention for the vice presidency.

Bigger Victory Predicted
Hall said it is his feeling the republican campaign will start around Sept. 15 and last six weeks. He said he couldn't say whether Eisenhower will kick it off with a major speech.

Campaign headquarters will remain in Washington, Hall said, and the GOP has budgeted seven million dollars for the presidential campaign and the House and Senate campaigns.

The GOP leader predicted, incidentally, that the party will win even more impressively than in 1952, regain control of House and Senate, and carry more than the four Southern states Eisenhower took four years ago.

Auto Industry Not Hurt By Steel Strike, Claim
DENVER (AP)—The steel strike which has tied up sources of industries has had no effect on the automotive industry, Walter P. Reuther, president of the United Automobile Workers, said here.

Reuther, here for a meeting of the Industrial Union Department of the AFL-CIO, said the steel strike would not harm the industry "unless it carries through a retooling period."

He explained the industry cut back production long before the steel dispute came to a head and added that manufacturers had accumulated a large inventory of steel.

He said the auto industry is starting its retooling operation now but "won't start production of new models until early this fall."

Lane County Firm Buys Douglas Tract Of Federal Timber

The Walter A. Woodard Lumber Co. of Cottage Grove was high bidder Wednesday for 13 million board feet of Umpqua National Forest timber located on the Bohemia Ranger District, 36 miles east of that city.

The company paid \$305,350 for timber appraised at \$328,035. It bid nearly 50 per cent more for 8,900,000 feet of Douglas fir and pine appraised at \$32.85. Selling price was \$32.75. Forest Service personnel said it was high price for Douglas fir timber on the forest. It is not an all time high.

A price of \$8.75 was paid for 4,100,000 feet of hemlock and other species, appraised for \$8.70.

One other bidder sought the timber. It was Bohemia Lumber Co. Forest Service personnel termed the bidding "spirited."

Drain Store Owner Wins Mexican Trip

Details of the accident were not known, but Moothart was believed to have stumbled and fell as he removed the asphalt, according to company Manager C. B. Sloan. tion ended the year with a deficit of approximately \$20.

Micelli's financial condition report showed \$124,730.21 under accounts receivable—the sum would decrease with payments from the fourth quarter which are not due yet.

His breakdown of the current costs of education was: Secondary \$1,370,074.54; elementary \$1,884,469.56.

In other business Wednesday, the school board elected Harold Hoyt as chairman and Robert Bashford as vice chairman. In the absence of Hoyt, Bashford presided.

Church Use Requested
The board referred to buildings and grounds Supt. Guy Davis a request from the Rev. Arthur Hoenish of the Christian and Missionary Alliance Church for use of the Huerest multipurpose room for church services. Davis is to estimate costs.

The board also referred back to its attorney George Neuner an architect's agreement with the Portland firm of Freeman, Hayship, Tutt & Hewlett for construction of the East Roseburg School. The attorney is to make additions.

Supt. Arthur Judd's progress report on the district's acquisition of federal funds for construction revealed that plans for the Huerest addition were now in Washington, D. C. for approval.

Judd said he expects "momentum" approval. He estimated that construction would begin by Sept. 1. He told the board that the federal office in Seattle had suggested additive building alternatives, rather than deductive.

Building and Grounds Supt. Davis presented a report of work under way in the district. In it, he said the protective drainage system at Joseph Lane Junior High School was 75 per cent complete. Maintenance work is being done in schools throughout District 4.

The board accepted the \$3,250 bid of Trowbridge Electric Co. to remove the high voltage wire at Roseburg High School. Money for the removal was allotted earlier in the budget.

In final action, board members agreed formally to the \$3,250 purchase price for the Thomas Kerr property in East Roseburg. A downpayment of \$6,650 will be made by the district, with the \$15,850 balance to be paid by June 30, 1957. The site will house the East Roseburg School. A sum of \$2,500 was authorized to construct an access road from Ramp Road to the site, upon recommendation of Supt. M. C. Deller.

The board will hold its next regular meeting on July 25. By unanimous action Wednesday, the group agreed to hold two regular meetings each month.
