

Legislators Table Angling Agreement

SALEM, Ore. — Some Oregon legislators suspected Friday there is something "fishy" about relations with neighboring Washington state.

Two years ago, Oregon reduced its non-resident angling fee from \$15 to \$10 to coincide with Washington. Now Oregon legislators have learned the Washington Legislature approved a bill raising that state's non-resident fishing permit to \$15.

So the House Fish and Game Committee Friday decided to table a bill calling for a reciprocal non-resident angling agreement with both Washington and Idaho.

In a more generous mood, the committee approved a bill broadening the daily angling permit. Instead of the present \$5 fee for seven days for non-residents only, the committee recommended a bargain rate of \$1 daily for both residents and non-residents.

The committee thinks it will encourage more family groups and cost them considerably less. However, if finally approved, the bargain wouldn't become effective until Jan. 1, 1938.

13 White Youths Charged In Death Of Young Negro

CHICAGO, Ill. — A Cook County Grand Jury reportedly has returned murder and conspiracy true bills against 13 white youths in the hammer slaying of a teenage Negro on a South Side street corner.

The jury yesterday questioned five witnesses about the fatal bludgeoning of Alvin Palmer, 17, Monday night as he waited for a bus.

One witness, Wilmore Johnson, 41, a Negro, said police he was waiting with Palmer at the bus stop when a white youth, brandishing a hammer, attacked the Negro youth for no apparent reason.

Police later seized Joseph Schwartz, 17, who they said admitted he clubbed Palmer after touring the streets with two carloads of other teenagers.

State's Atty. Benjamin Admowski said he will seek the death penalty for all those indicted for murder in the slaying.

Elmer Palmer, 3, the dead youth's father, and three policemen who took part in the arrest of the youths also testified before the jury.

British Shipbuilders Start Walkout Series

LONDON, Eng. — Britain's shipbuilders began quitting work today in the first of a series of industrial walkouts that could idle nearly three million men in a week.

The first of 200,000 shipbuilders walked off their jobs early this morning. Over 100,000 more today are scheduled to be joined by 200,000 engineering workers.

All of the, represented by the Confederation of Shipbuilding and Engineering Unions, are demanding a 10 per cent pay increase. Their average week now is 12 pounds, 18 shillings and 10 pence (\$26.24) weekly, some two pounds (\$5.00) above the national average.

Unidentified Car Hits No Parking Sign, Faucet

A no parking sign and a water faucet were a little worse for the wear Friday after an unidentified car managed to knock out both at the east end of the Oak Street Bridge in Roseburg.

Roseburg police were called to 308 SE Oak Ave. about 9 a.m. Friday on a complaint by Robert Skelton. The police noted that car tracks indicated a car had turned left off the bridge and kept turning until it went over the north curb.

The tracks made a 12-foot trail across the lawn, the police said, and a "no parking" sign and water faucet were in the path.

QUEEN MAY VISIT

LONDON, Eng. — The independent Daily Sketch said today President Eisenhower has invited Queen Elizabeth II and Prince Philip to visit the United States and will discuss the trip with Prime Minister Macmillan in Bermuda.

The Sketch also reported Prince Charles and Princess Anne may accompany their parents on the trip.

Beck Delays Answer On Financial Records

records went out nearly a month ago.

There have been allegations that union funds were used to pay some of Beck's personal expenses. Late in Friday's hearing the committee produced several checks amounting to more than \$14,000 and said the Teamsters money went to Nathan T. Shafferman, Chicago labor relations consultant to employers. The consultant said he once served in that capacity for Sears, Roebuck & Co.

The checks were signed in 1932 and 1933 by Beck and Frank Brewster, chairman of the 11-state Western Conference of Teamsters.

Brewster testified that he didn't know why the money was paid. However, he said Beck used to pay Shafferman to make speeches to Teamsters Union groups as "labor-management authority."

No further explanation of the alleged payments to Shafferman was offered at the hearing. But Robert Kennedy, committee counsel, said later hearings will deal with what happened to the union money.

Also in recess for the weekend was a federal Grand Jury probing bribery charges against Teamsters Union Vice President James R. Hoffa. He is free on \$25,000 bond on charges he paid a New York attorney to get listed by the Senate committee and then to feed him committee secrets.

The Grand Jury has heard from the attorney, John Cheasty, and Hoffa's red-headed secretary, Mrs. Dorothy P. DeLoach, as well as from Kennedy and a number of FBI agents. The panel will meet again Monday.

Brewster, the West Coast Teamsters boss, flatly denied that he or other Teamsters officials conspired to bribe public officials or to take over gambling, prostitution and other forms of vice in Portland.

Brewster acknowledged he used Teamsters Union funds to pay travel expenses for his horse trainer and jockey. He said he was going to have an audit made to see how much he actually did owe the union, with the idea of paying it back.

Brewster contended whatever union money he spent on horse racing was a good investment for the union because he said some of it went for tickets for people who helped the union. Similarly, he said big cars bought with union funds were a good thing for the union, too.

"I've let employers use 'em (the cars) as much or more as I have," Brewster said.

Judy Garland Sues Columbia For Million

NEW YORK, N.Y. — Singer Judy Garland has filed a \$1,000,000 breach of contract and libel suit against the Columbia Broadcasting System.

Mrs. Garland's action, filed yesterday in Federal Court, said that on Jan. 8 CBS authorized and induced publication of "false and defamatory matter" concerning her in newspapers and other publications.

She charged the network issued such statements as that she is "known for a highly developed inferiority complex," did not "want to work because something is bothering her," and "I don't know but I wouldn't be surprised if it's because she thinks she's terribly fat."

CBS said it had no comment on the suit.

Mrs. Garland seeks a million dollars for the alleged libel, and an additional \$300,000 for alleged breach of contract.

Funeral For Four Family Members Slated Monday

ALBANY, N.Y. — Funeral services are to be held Monday at Selma, Calif., for four members of a family fatally injured in a highway collision near here.

Norman Paul Launer, 48, and his son, John Paul Launer, 20, died Wednesday in a hospital here. Two other sons, Joseph Myron Launer, 17, and Lloyd Norman Launer, 22, were killed outright in the crash Sunday.

The 18-year-old widow of Lloyd Launer is in critical condition at the hospital. She was the only one to survive when the car collided with a freight truck after the California family was driving to Oregon City for the wedding of Mrs. Lloyd Launer's sister.

Other surviving members of the family are the mother, Mrs. Alma Launer, and a son, Donald G. Launer. They said funeral services would be held at the First Presbyterian Church in Selma at 2:30 p.m.

It was only by chance that Mrs. Alma Launer was not involved in the accident. She had left the family car when the car broke down in Southern Oregon, and made the rest of the trip by bus.

Midwest Policy Target Of Senate Committee

WASHINGTON, D.C. — Two special Senate committees are preparing to launch inquiries next week into Midwest farm policy and the Eisenhower administration's foreign aid program.

Secretary of State Dulles is scheduled to appear Monday at a closed session of the Senate Foreign Relations Committee. He will brief members on the recent Southeast Asia Treaty SEATO conference and the forthcoming Anglo-American talks in Bermuda.

But there was more congressional interest in the appearance Monday of C. D. Jackson, former special assistant to President Eisenhower, before a special subcommittee headed by Sen. Fulbright (D-Ark.).

Jackson has agreed to elaborate on a speech he made in Tokyo several days ago concerning the administration's decision to withdraw its offer to help Egypt build the Aswan Dam. Announcement of the decision last summer was followed immediately by Egyptian seizure of the Suez Canal.

Giant Meteor Blazes Way Across Southeast

than an hour to clear the chamber of gas. And physicians say the hydrocyanic gas attacks the brain instantly.

Abbott's conviction was based on circumstantial evidence.

Stephanie, daughter of Dr. and Mrs. Charles Bryan of Berkeley, Calif., died April 25, 1935. No one saw her abducted. No one except her assailant saw her killed.

On July 15 her purse was found by Abbott's wife in the basement of the Abbott home in nearby Alameda. The girl's decomposed body was found in a shallow hillside grave near her Trinity County cabin five days later.

Abbott proclaimed his innocence in the end.

Late last night, a lie detector expert said his findings after interviewing Abbott convinced him the man was guilty. The expert, Hal Reidel, retired Berkeley police inspector, said the trial court ruled the evidence inadmissible.

House Votes To Keep Present Business Taxes

WASHINGTON, D.C. — The House passed and sent to the Senate Thursday a bill to keep business taxes at their present 30-billion-dollar annual level for another year.

general welfare of the county," he declared. "The court should be trying to keep the purchasing power of the county up."

The business representative went on to say he couldn't see how, if the layoff was to be only 10 or 12, it would result in much of a saving during the remaining four months of the fiscal year. The saving by such a layoff would amount only to \$12,000. Butts said, and noted that he would be "nothing that couldn't be made up."

He said he had been told that six or seven other road workers were to be notified Friday evening that they were being laid off. Others told to take their vacation, he stated, it would seem better, he said, to postpone forcing vacations until after July and keep them in productive work.

County Judge V. J. Jackson replied that he didn't know how many had been laid off. He said the road department was to lay a main of Jackson declared.

He went on to say the county would be even shorter of funds next year because of a slowdown in timber sales and prices paid for OAC lumber — a primary source of money for Douglas County. Revenues are estimated as much as a million dollars, he said.
