

House Committee Slashes \$2 1/2 Billion From Budget For Defense Department

WASHINGTON (AP)—The House today voted a \$2,250,000,000 cut in new defense department funds. It said the military threat to the free world "appears, in certain respects, to have somewhat abated."

But it cautioned against "complacency" as it recommended \$3,541,225,000 in new appropriations for the Army, the Navy and the Air Force for the fiscal year starting July 1.

Gen. Cantave announced dissolution of a seven-man Executive Council, which has been attempting to rule until presidential elections could be held June 16. The turnover was accomplished without violence.
