Tight Pitching Duels, Rain In Prospect For State Meet

PORTLAND — Tight pitching duels are expected Saturday night in the finale of the state high school playoffs, weather permitting.

Forecasters warned there may be showers in the afternoon, followed by rain at night.

The teams are scheduled to play in a triple-header at Multnomah Stadium, with games for the class B, class A-2 and class A-1 titles, in that order, beginning at 5 p.m.

Eight Meet Records Broken in MAA Meet

SAN DIEGO — Small college track and field stars set their sights on possible new records Saturday morning in the finals of the National Amateur Athletic Association meet.

Eight meet records fell to the preliminaries Friday and more new standards were expected in the meeting's first round survival in Saturday's championships.

Bobby Morrow, fleet-footed Olympic sprint champion from Abilene Christian College in Texas, set one new mark when he broke the tape at 21.3 seconds for an easy victory in the 220-yard dash. Saturday he raced against Ollan Cassell, East Tennessee State who was right behind Morrow in the opening event Friday.

The most spectacular new mark came as John Froman of Parkland Lutheran College at Parkland, Wash., threw the javelin 243 feet 11 inches. His toss was the second best collegiate mark of the year.

Two arch rivals, Elias Gilbert of Winston Salem College in North Carolina and Dave Klieker of Whitman College, Walla Walla, Wash., were paired off in the hurdles. Both won their respective heats with Gilbert setting meet records of 13.8 seconds in the 120-yard high hurdles and 23.4 seconds in the 220-yard lows.

Klieker set a new mark in the 440-yard hurdles.

Besides the javelin, finals were held in the broad jump and steeplechase, both of which also resulted in new marks. Jim Gable of Prairie View, Tex., leaped 24 feet 9 inches and Kent Osborne of East Tennessee State ran the 3,000-meter steeplechase in 9:45.8.

The other record was set in the preliminaries of the discus throw by Ronald Anderson of McPherson College, McPherson, Kan., with a 167-foot 5-inch heave.

Title Vacate Ultimatum Given Archie Moore

DETROIT — The National Boxing Assn. says Archie Moore must defend his light heavyweight crown in a United States bout by July 7 or relinquish the title.

The ultimatum by NBA President Floyd Stevens was the latest in repeated "put it on the line or get out" orders to the ancient vagabond. But this time the NBA says its means business.

It notified Moore yesterday that he is suspended and that if he doesn't get into a U.S. fight within the month his title will be declared vacant and given to the winner of a series of elimination bouts.

The latest decree stems from Moore's failure to meet Tony Anthony of New York in a Detroit fight scheduled for last night.

Moore, in Germany on a European tour, threatened to sue the NBA for one million dollars "for attempting to deprive me of my right to make a livelihood."

"Let him sue," replied Stevens. The NBA president said Moore had agreed to fight the winner of the Anthony-Chuck Spieser bout held here last April. Anthony knocked out Spieser in the third round.

Stevens said Moore told him May 4 that he would fight Anthony here if he was guaranteed \$100,000.

"We're concerned with a reasonable defense of the title and Moore's promise to fight the winner of the Anthony-Spieser fight," Stevens said. "We're not interested in the money."

Stevens said he didn't think he'd receive a title defense in Europe against a European fighter.

The story goes that Jack Sanford has to threaten a club official with a poke in the nose to stick with the Philadelphia Phillies this spring. It seems incredible now that the fast-balling righthander is 7-1 and tops the National League with an .875 percentage.

In early April, however, it almost figured that Sanford might have to put the slug on somebody to ever make the majors. He was 27 and had kicked around in the minors for seven years.
