

Meat Packing Plant Suffers Fire Damage

PORTLAND *AP* — Damage estimated between \$8,000 and \$10,000 was caused by fire of undetermined origin at the Olympic Meat Packing Co. plant at nearby Parkrose early Monday. Roy Shaw, owner, estimates damage to the building at \$5,000 and \$6,500 to equipment and stock. A pharmacy next door was damaged slightly. The building adjoins the district fire station.

VACCINE IN SEPTEMBER
PORTLAND *AP* — The State Board of Health said here that Oregon probably will receive no anti-Asiatic influenza vaccine before early September. The state, which has had three cases of the disease, will not receive any of the 500,000 shots released this week. Oregon, however, probably will receive some of the eight million shots of the vaccine due for release early next month.

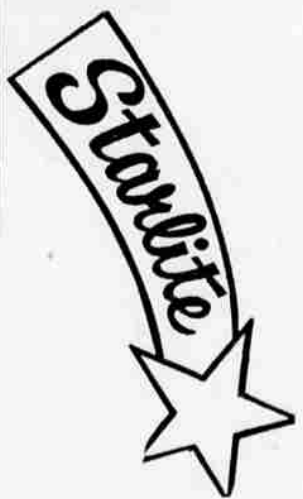
