SPEED CONTROL STUDIED

(Reprinted from the Salem Capital Journal)

The official study of the virtues of two systems of highway speed control now is underway, and we're pleased. This is the study we requested without much hope in an editorial several months ago. Since most agencies of state government involved are happy with the present basic rule law, we hadn't expected such a thorough investigation, if any at all.

But a committee appointed by Motor Vehicles Director Jim Johnson had its first meeting and held a hearing at which groups presented arguments. Officials of other states using both systems and combinations of them also will be quizzed by mail. A report on the findings will be issued about a month from now.

Although the committee is loaded, we're still happy with it. On it are State Traffic Engineer F. B. Crandall and Lt. Farley Morgan of State Police, two of the basic rule's most eloquent proponents.

But if they can prove their points against all comers, we can ask little more.

The committee will come back with one of four recommendations:

1. That the basic rule be kept as it is (with only suggested maximum speeds for normal conditions).
2. That the basic rule be kept, but that hard and fast maximums be set for normal conditions.
3. That there be fixed speed limits everywhere.
4. That there be fixed speed limits inside cities and the basic rule outside.

Attorney General Robert Y. Thornton recently came out for plan 2. The Assn. of Oregon City Police Officers only last week advocated plan 4. State police in the past, at least, have favored plan 1. So far as we know, no group or authoritative individual in the state has come out publicly for plan 3 which means abandonment of the basic rule in entirety.

The basic rule for those who have neglected their driver's manual, says that a driver must keep his vehicle under control at all times and pace his speed to road conditions, weather, traffic and other hazards. It has been called "the rule of reason," and Oregon has had it since 1932. Only recently has it come under considerable attack.

Although we lean toward plan 2, we realize that much of the opposition to the basic rule is based on a misconception. The basic rule, contrary to some critics, has not failed obviously. Statistics are deceiving. Oregon is a much safer place to drive than it was only a few years ago. The accident rate per million miles has been just about cut in half in the past decade. The fatality toll creeps up slowly only because there are twice as many cars now, each of which travels farther per year.

The trouble with the basic rule is only that it makes enforcement a bit tricky. Drivers have been pinched on the freeway driving more than 100 m.p.h., and have been acquitted because the officer could not prove beyond a doubt that a danger had been created. Other drivers haven't even been whistled down at 85 because this courtroom difficulty has been anticipated.

The trouble with a fixed speed is that it is hard to set the correct speed for each stretch of road and expensive to post it. And drivers vary. Some can drive 70 on good road. Others are shaky at 60, proponents of the basic rule insist. Too, it isn't right to put a fixed limit on a good driver in good conditions. For example, such a limit might be 60 for the average highway. Yet this highway dry, in daylight, in light traffic might not be a hazard at 70 or 75. Yet all traffic would be slowed — or the officer would be bound to arrest one safe driver after another.

Unfortunately, statistics are no help. Too many conditions vary, and it's difficult to make an accurate comparison of fixed speed and basic rule states. Majority rule is no help either, since just about half the states have fixed speeds.

It's a great argument, with all the sparring room in the world, and we're glad it finally is being aired.

If you feel that the GOP program is better for our country, vote for Republicans.

Remember that POLITICS is the art of kidding people into voting for somebody.

STATESMANSHIP is a miraculous combination of patriotism, wisdom, sound judgment and the COURAGE to use these qualities for the betterment of our country.

Our great need is more statesmen in politics.

Let's close this piece with a quotation from Abraham Lincoln: "You can not bring prosperity by discouraging thrift. You can not strengthen the weak by weakening the strong. You can not help the wage earner by pulling down the wage payer."
