

Two-Pronged Bills Aimed To Cure Union Corruption Meet Business Opposition

WASHINGTON (AP)—Washington is a city of strange lineups. One of them currently involves a couple of Senate-passed bills supposedly aimed at curbing corruption in unions and in labor-management relations, based on the scandals disclosed in Senate hearings. But what do we find? Business suddenly is fighting the proposals in their present form—most of organized labor is actively supporting them.

One causing a storm in the House Labor Committee attempts to safeguard worker welfare and pension funds, now estimated to be worth over \$5 billion dollars and growing fast. A goldfish bowl treatment is proposed, requiring full, regular reporting of all fund operations to the government, with penalties for fraud.

The other Senate-passed bill, now tucked away in House Speaker Sam Rayburn's desk, is the welfare fund bill out of the way, seeks to throttle racketeering by either unions or employers in the labor field.

Here again the technique is to require detailed reporting on union affairs and funds, along with employer expenditures in labor relations. The reports would go to the U. S. Labor Department, which would have power to prosecute violations.

Other features of this bill would bar convicted crooks from holding union office, require secret-ballot in union elections for limited terms, and let union members sue to recover stolen union funds or property.

Business Dismissals
But it also contains some provisions that business groups are opposing. Leading the fight are the two main business organizations, the National Assn. of Manufacturers and the U. S. Chamber of Com-

merce, both opposed to the two pending labor bills. Labor is largely represented by the AFL-CIO, which is for the bills. Presumably, not all business groups support the one stand, nor all labor leaders the other. But that's the lineup.

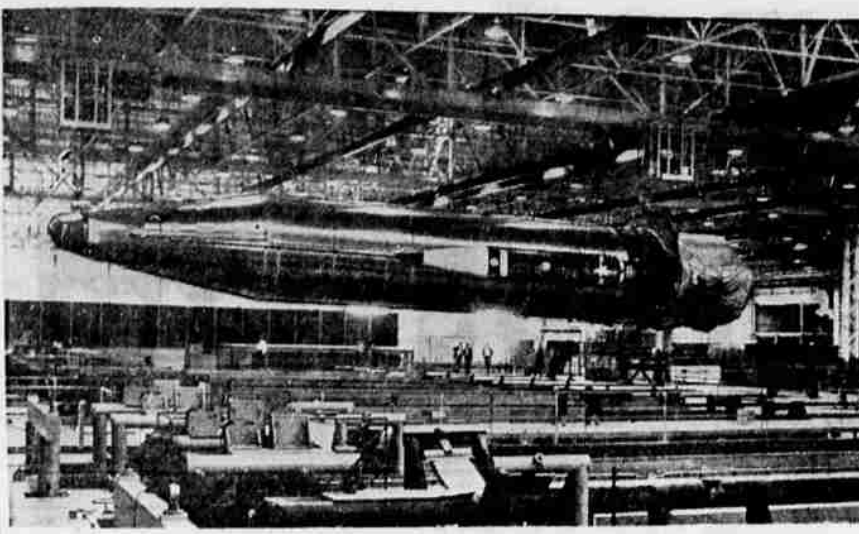
Why? Take the welfare fund reporting bill first. Business favors regulating funds in which unions have a voice, but opposes disclosing financial operations of funds run solely by employers. Labor says this would give labor otherwise secret data which could be useful in bargaining.

More than 90 per cent of such funds are employer-operated. But business contends that scandals have developed only in the relatively few union-run funds. Labor says funds should be safeguarded to preclude any scandal possibility.

Insurance Also Opposes
Insurance companies, particularly, are encouraging the business opposition. Many of the welfare plans consist of policies purchased from insurance firms. They resist having to disclose the information. On the second measure, business objects to revealing its labor relations expenditures.

The employer groups also have balked at a provision to make management representatives submit the non-Communist oaths which have been required all along from labor leaders. Business claims there's been no evidence of Communist infiltration of business management. The unions say what's good for them is good for their business counterparts.

Business seems to prefer no bills at all to the measures in their present form.

Hungarians In N. Y. Stage Noisy March Against Russians

NEW YORK (AP)—Hungarian pickets marched noisily around the Soviet headquarters at the United Nations Sunday, shouting intermittently "Drop dead, Khrushchev," "Red murderers" and "We love Hungary."

New York City police, mindful of a recent violent demonstration by Hungarians outside the offices, took extra precautions. There were about 250 marchers and 147 uniformed policemen and 35 detectives around the Manhattan building. Other officers were in reserve a few blocks away.

The leader of the latest demonstration, the Rev. Imre Kovacs, pastor of the First Hungarian Reformed Church in Manhattan, asked the pickets to return every day this week through Saturday. "We should have 10,000 American boys and girls marching with us," he said.

The pickets say they are trying to annoy the Soviets out of the United Nations. They carried signs reading "Now it is your turn to get out," "Stop butchering Hungarian patriots" and "Khrushchev is Soviet crime minister."

The demonstration, like other similar protests recently in various world capitals, was to call attention to the execution of former Hungarian Premier Imre Nagy and other leaders of the 1956 Hungarian rebellion.

Damascus, Moscow and East European satellite capitals. Here in Beirut, rent for more than two months by a revolt against pro-Western President Camille Chamoun, rebels in the Muslim quarter celebrated with a wild firing of guns.

Communist broadcasts said the coup was carried out because Iraq had planned to give military aid to the Lebanese government. Baghdad Radio named Brig. Gen. Abdel Karim Kassab leader of the coup. He was said to have named a 13-man cabinet and a three-man sovereignty council headed by Lt. Gen. Naguib El Ribaci. The council, it was announced, would exercise sovereignty until a plebiscite for president could be held.

Army Purge Stated
Communist broadcasts in Cairo said the new revolutionary command announced a purge of army commanders, abolition of the monarchy, and declared an official holiday.

One of Lebanon's rebel leaders, Sabeh Salam, said in Beirut that the development "certainly gives the Lebanese rebels new heart. This reflects once more feelings of genuine Arab nationalism which the West so far has failed to recognize. It's time now for the West to recognize this feeling."

The U. S. embassy urged the 4,000 Americans in Lebanon to take special precautions until the situation in Iraq is clarified. Lebanese President Chamoun has been hanging on in the face of 66 days of rebellion by elements friendly to Nasser. Recently there has been talk of some kind of compromise as the rebels weakened.

LONDON (AP)—The Italian government reported Monday the British Embassy in Baghdad has been ransacked and set on fire. The report said the ambassador and embassy staff were safe.

Missile Launching Flop Due To Electronic Unit

CAPE CANAVERAL, Fla. (AP)—The launching of an Atlas intercontinental ballistic missile was postponed Friday because a second electronic part failed at the last second, it was learned Monday.

A source close to the ICBM program declined to elaborate, but he indicated that the trouble was minor. Another attempt to fire the two-million-dollar missile, fully powered for the first time, is expected some time this week.

The 85-foot rocket housed the three engines necessary for full intercontinental range. In eight previous tests only the two boosters were used over a distance of some 800 miles.

After the Friday countdown reached zero, the engines roared for about 10 seconds before they cut off. The missile reportedly was to be fired some 2,500 miles to test the propulsion system.

AUW, Big Three Resume Parley; Both Sides Firm

DETROIT (AP)—The United Auto Workers and the auto industry's Big Three return to the bargaining table today.

Negotiations for new contracts at Ford, General Motors and Chrysler resume in an atmosphere laden with questions.

Chief among them were the continuing effect of the recession and the role to be played by the industry's backlog of unsold 1958 model cars.

Presumably, the UAW and the companies were starting on a virtually all over again from the point they stood at in late March when these negotiations first began.

There had been no serious concession from either side up to the time the auto contracts expired during the Memorial Day weekend. The companies have continued operations without contracts.

The UAW has been taking a strike vote at all three companies. It reports its rank and file has favored a strike by a 90 per cent majority if necessary to enforce demands.

Both Sides Stand Firm
As negotiations resumed, the UAW apparently still stood on its original demands for a pay boost of 10 cents an hour, improved lay-off benefits, improved pensions, and other concessions. The average auto worker pay is \$2.50 an hour.

All through the months of past deadlock the companies reported they were inflexible on preserving past wage formulas for another two years.

This would mean an increase of 16 cents an hour spread over the 16 years in cost of living allowances and productivity increases.

Adams To Resign As Ike's Aide, GOP Report

DETROIT (AP)—The Detroit News said Saturday top-ranking Republican sources have disclosed that Sherman Adams plans to quit his White House post over the Labor Day weekend.

The paper said in a copyrighted story from its Washington bureau that Adams, President Eisenhower's top aide, is seeking a way of making a graceful exit.

Many Republicans contend Adams has outlived his usefulness because of disclosures of his association with industrialist Bernard Goldfine, the paper said, adding that these Republicans "want the presidential assistant removed from the area of controversy as long before the Nov. 4 elections as possible."

The paper said that White House advisers argue that to quit while Congress is in session would "open the door to a deluge of castigation from Democratic senators and congressmen."

Congress may adjourn as early as Aug. 16 but it could run through Aug. 30, the eve of the Labor Day weekend.

The paper did not further identify its source. It said that details of the separation are still to be worked out by the White House staff. The decision to quit is Adams' own, not the President's, the paper reported.

Washington Fire Blackens 4,000 Acres Of Timber

FORD, Wash. (AP)—A timber and brush blaze that at one time threatened Ford and the nearby community of Uranium City was brought under control Sunday evening by 400 weary fire fighters who took advantage of a shifting wind.

Volunteers were on duty Monday to watch smoldering stumps and guard against another outbreak of the fire that blackened some 4,000 acres of timber, grass and brush. Some wheat fields were also burned.

The blaze was pushed rapidly along by wind Saturday and for a time seemed a threat to the large Spokane County town of Deer Park. Flames came within a few hundred yards of both Ford and Uranium City.

Then a sudden wind shift about midnight Saturday started the fire blowing back towards itself. Fire crews immediately threw up fire lines.

The blaze was cresting through the tops of trees at an estimated 40 miles an hour at one time Sunday night.

More than 300 airmen joined the fire fighting crews.

Glendale Man Dies While Sightseeing

Burt W. Looney, 79, Glendale, died from an apparent heart attack while sightseeing in the mountains Sunday, according to the Douglas County coroner's office.

Looney is survived by two sons, Malcolm of Klamath Falls, and Tony of Springfield.

Taxi Driver Wounded, Jealous Husband Held

PORTLAND (AP)—A 32-year-old taxicab driver was shot in the neck early Sunday. Police accused a jealous husband.

Joseph W. Gage was taken to a hospital after the shooting. Attendees said the bullet narrowly missed the jugular vein, but his condition was satisfactory.

Police booked Richard D. Blean, 35, for a charge of assault with a dangerous weapon and set bond at \$5,000. Police said Blean and his wife separated Thursday, but that Blean went back early Sunday and the shooting followed.

Foster Parents Charged In Fatal Child Beating

PATERSON, N.J. (AP)—Eileen Graham was only an infant when her natural parents were found guilty of neglect and she became a ward of the state.

Today, the foster parents, Mr. and Mrs. Victor Corbo, face arraignment on charges of beating her to death.

The 3-year-old girl was found dead in her crib of a brain hemorrhage Friday morning, her little body covered with bruises.

Police said three of her brothers and a sister, all wards of the Corbos since 1956, were found suffering from malnutrition.

Rebels In Cuba Expected To Free Americans Today

QUANTANAMO, Cuba (AP)—Cuban rebels were expected to begin releasing their 25 captive American servicemen this afternoon after holding them more than two weeks.

Word of the anticipated release came from U.S. Consul Park Wollam, who has been dickering with Fidel Castro and his lieutenants in the rebel-occupied province for the captives' return.

Twenty-eight of the sailors and Marines were kidnapped June 26 on a bus ride through the Cuban countryside and two more were grabbed near the base. One of the latter has been returned.

The rebels' recent decision to start freeing the servicemen appeared to indicate they have given up hope the kidnappings would help them wheedle concessions from the United States.

They had been seeking recognition as genuine revolutionaries in a war of unorganized revolutionaries and hoped this might lead to a promise that American aid to President Fulgencio Batista's government would be shut off.

One benefit the rebels have gained was a letup in air attacks by government forces to keep from harming the captives. The rebels have gained valuable time to regroup their forces.

PORTLAND (AP)—An automobile crash killed a Longview, Wash., woman at a northern entrance to Portland Monday.

Mrs. Irene McCullough, 30, was injured fatally when the automobile left Denver Ave. a half-mile south of the Pacific Highway bridge across the Columbia River.

Her husband, Samuel, 38, was thrown from the car. He was taken to Emanuel Hospital, where attendants said he was in critical condition.
