New Suit Slapped On Evans Products

DETROIT (AP)—A suit charging Evans Products Co. with violating securities and exchange commission regulations was filed in U.S. district court here Thursday by four stockholders.

The suit contends the suburban Plymouth, Mich., firm violated the regulations by failing to give its 5,000 stockholders pertinent information about a proposed merger with Aberdeen Plywood & Veneer Inc. of Aberdeen, Wash.

The same stockholders filed a similar suit in Wayne County circuit court Monday.

Both suits ask that Evans and its stockholders meet next Wednesday postponed for at least two months and the same directors be elected annually instead of for staggered terms.

A hearing on the circuit court suit was scheduled Friday and one on the federal suit Monday.

The suing stockholders are Frank L. Webb of Chicago; John K. Fiddes of Pataskie, Ill.; and Howard Jenson and Walter Ganser of Michigan City, Ind.

The federal suit contends too little time was allowed for study of the merger proposal and that proxy material mailed out by Evans management failed to disclose the background of the merger plans.
