Judgements

Elmer Phillips vs. State Industrial Accident Commission. On stipulation of the parties, judgment of compensation to plaintiff for permanent partial disability equal to 12 1/2 per cent loss function of a forearm for injuries to plaintiff's left arm, wrist and hand.

Roy, Victor and A. J. Rice, co-partners doing business as A. B. Rice Logging Co., vs. Homer Rhodes. On default of defendant, judgment entered for plaintiffs in sum of \$11,743 plus interest and costs on an amount alleged due on unpaid promissory note dated May 21, 1959.

David H. Cameron, Department of Employment Commissioner vs. Roy Oliver Holloway Sawmill. On default of defendant, judgment granted plaintiff for \$148.62, plus interest and costs.

Felix S. Samarron vs. State Industrial Accident Commission. On stipulation of the parties, judgment order entered remanding case back to commission for payment of additional compensation for permanent partial disability increased from 10 per cent loss function of an arm and 75 per cent loss function of right thumb to 35 per cent loss for the arm and unchanged amount for loss of thumb.

Eugene S. Marshall vs. State Industrial Accident Commission. On stipulation of the parties, case remanded to the commission for compensation for unscheduled injuries and disabilities equal to 35 per cent loss function of an arm, being an increase of 15 per cent above compensation previously allowed for permanent partial disability.

David H. Cameron, Department of Employment Commissioner, vs. R. G. and H. G. Jenkins, doing business as R & H Logging. On default of defendant, judgment entered for plaintiff in sum of \$439.32, plus interest and costs.

Carl Johnson vs. Ebert Lane, also known as Bert Lane, doing business as Roseburg Junk Co. Based on stipulation of parties, judgment entered for plaintiff for \$370 without costs.

Laverne K. and Ruth A. Howard vs. Roger and Donna M. Hutchinson. On default of the defendants, interlocutory decree entered favoring plaintiff that defendants pay \$6,158.87 alleged owing and due on property described within 30 days or foreclosure proceedings to be instituted.

Lola F. Paroz vs. Raynor L. Clack, Marian A. Clack and Thomas Ireland Sr. Decree entered granting plaintiff judgment against the Clacks for \$1,370.21 with mortgage to be foreclosed on personal property. Plaintiff's interest was decreed superior to that of the other named defendant.

David Ortiz vs. State Industrial Accident Commission. On stipulation of the parties, judgment entered remanding case back to defendant for payment of compensation for permanent partial disability equal to 90 per cent loss function of an arm for unscheduled disability for injuries to plaintiff's back, being an increase of 15 per cent.

Metropolitan Life Insurance Co. vs. Theodore A. and Betty A. Erna. On default of defendants, decree of foreclosure entered. Order of court that plaintiff recover from defendant Theodore A. Erna the following sums: \$5,853.77, plus \$22.59 mortgage foreclosure costs, \$300 attorney fees and \$48.86 costs. Ordered that mortgage of Dec. 15, 1959, be foreclosed on Lot 12, Block 5, Harbor Addition to Ridge.
