Fat Lamb Show Slated Saturday At Fairgrounds

The 23rd annual Douglas County Fat Lamb Show and Barbecue is scheduled Saturday at the county fairgrounds.

Almost \$300 in prize money will be awarded, as well as a host of ribbons in several different classes. Among these will be the traditional Sheepdog trials.

At noon, another traditional event, the lamb barbecue is scheduled.

The show starts at 10 a.m. with the junior singles judging. Cash prizes will be awarded for the top ten places in Romney, Lincoln, Corriedale, Cheviot, Columbia, Targhee and Romedale wool breeds and also to the top 10 down breeds of Hampshire, Suffolk, Southdown and Dorset.

Showmanship Planned

The 4-H Showmanship is scheduled at 10:40 a.m. for 4-H members exhibiting lambs. Ribbons will be awarded.

The open singles judging starts at 11, with cash prizes going to the wool breeds and down breeds.

High-Altitude A-Blast Ready

HONOLULU (AP)—The first of the government's high-altitude nuclear tests is scheduled for 10 p.m. today—3 a.m. Eastern Standard Time Saturday.

The flash is expected to be seen in Hawaii, about 700 miles northeast of the Johnston Island test site, said the announcement of the blast issue by the Pearl Harbor headquarters of Joint Task Force 8.

The announcement said the shot will be the first of three and possibly four high-altitude blasts. The first will have a force of less than one megaton. A megaton is equivalent to one million tons of TNT. It will be detonated probably at an altitude of 30 to 40 miles.

A spokesman said weather or other factors could delay the test. If there is a delay of more than five hours, the shot will be scheduled another day, he added.

Airlines have been notified by the Federal Aviation Agency that high-frequency radio communications will be affected.

Airlines plan to change schedules to adjust to the communications blackout. Japan Air Lines said it will route planes between Honolulu and Tokyo 200 to 250 miles north of their regular course.

New Television Translator Set

Roseburg television viewers whose sets have ultra high frequency converters can now bring KOIN-TV into their homes over UHF channel 83.

Eugene Ralle said that he has completed installation of equipment on Mt. Nebo which picks up a signal relayed from Mt. Scott and converts the signal from VHF to UHF.

Federal Communications Commission has granted Ralle the authority to use channel 83. He stated that the signal is coming in very good now, and there is every indication it will remain satisfactory.

He stated that delays from earlier announcements were caused by getting the necessary authority to place the channel on the air. It was also necessary to install the Mt. Scott signal equipment. He also has plans to increase the power about 10 fold.

Ralle has installed the equipment on his own, with only limited financial aid from volunteers.

Food Supply Short; Reds Boost Prices

MOSCOW (AP)—The Soviet Union today hiked consumer prices of meat and butter to finance the country's lagging agricultural program in the face of food shortages.

Butter—up 25 per cent—will cost \$1.83 a pound; pork and beef—up 30 per cent—will retail for 88 cents a pound.

The effect of the increases are measured against salaries much lower than those in most foreign countries. A semi-skilled Soviet worker gets the equivalent of \$88 a month, professional and semi-professional people about \$222 a month.

The government announcement said that the increased charges were necessary because there was no other means of raising money to pay the increased expenses on farms.

Blame was placed in part upon the United States. The statement said it was not possible to "switch funds to increasing the output of livestock products at the expense of the country's defensive capacity."

"We do not live in a vacuum. While imperialism exists, the danger of new wars will remain. It is no secret that international reaction, with the United States at the head, now is engaged in sabre rattling, conducts a feverish arms race and harbors plans for a surprise rocket nuclear attack on the U.S.S.R. and the other socialist countries. Its politicians and generals speak openly of this."

The order for the increase in prices was issued by the Communist party central committee and the government. Its effect was law since all stores are government stores and the prices are fixed by decree.

The statement said the cost of producing food, meat and butter had increased sharply because of the expenditures on mechanization on the farms.

The announcement made it plain that people in the cities are going to bear the lion's share of the burden of the increased prices. That will tend to level out the living standards of the city and country groups. Normally city people have lived better in the Soviet Union because of a sharp salary and income advantage accorded them from the time of the revolution.

The second batch of Sabin oral vaccine for the polio clinics in the county is expected to arrive in Roseburg today to be rushed to cold storage until Sunday.

The sponsoring Douglas County Medical Society has ordered 40,000 doses of the vaccine designed to provide immunity of Type III polio virus.

Dr. Louis Michalek, chairman of the clinic committee, said today it is possible the 34,000 who took the Type I vaccine may be topped at this clinic. He said this has been a common occurrence during clinics held elsewhere in the county.

Michalek emphasized that even though the Type I vaccine has not yet been taken, the second doses should be taken because each dose gives immunity to a different type of virus. The doses can be taken in any order, but a certain amount of time must elapse between each dose. Those who have not received the Type I can secure it from family physicians.

The second Sabin Oral Sunday clinic will start at 11 a.m. at five places in central Douglas County and at one clinic at Reedsport. The clinics will be operating until 6 p.m. A charge of 30 cents per dose will be made, with no family to pay more than \$2. The society spokesman said, however, that no one should stay away because he doesn't have the money. They will be given free in this case.

The central Douglas sites will be the Douglas County Fairgrounds and Joseph Lane Junior High in Roseburg, Winston Junior High, Tri-City Grade School and West Sutherland Grade School. The former site of the Roseburg High School has been changed to Joseph Lane because of baccalaureate which is scheduled at RHS Sunday night.

At Reedsport, the vaccine will be administered during the same hours at the Community Building. It also will be Type III.

Boys Camp Program Draws Approval At Juvenile Council Meeting Here

The voices of dissension were few at a public meeting of the Douglas County Juvenile Advisory Council Thursday night which drew about 50 people.

The subject of discussion was a youth camp for boys who had become delinquent. A site for such a camp has been offered by Miss Desda Wixson and her brother, McArthur, east of Myrtle Creek.

Featured speakers were Amos Reed, superintendent of MacLaren School for Boys in Woodburn; Circuit Judge Charles Woodrich; Juvenile Officer Julian Helleck; and council Chairman L. A. Suiter.

Reed reported that the 11-year camp program operated by MacLaren has been an extreme success. He said apprehension of residents of areas where the two MacLaren camps have been established was quickly dispelled. He estimated the boys at the camps do \$40,000 a year worth of work in such things as improving parks.

In addition, he said, camp costs amount to about half per boy as much as institutional care.

He said he thinks he has the support of the Board of Control in establishing two more camps within the next four years.

"They are not panaceas, but where the boys are receptive, the effects have been extremely beneficial," he concluded.

Alternatives Needed

Judge Woodrich said that when he took office as juvenile judge seven years ago, he was given only the alternative of returning delinquent youngsters to their homes or sending them to MacLaren. He insisted other alternatives were needed.

One addition was the creation of a foster home program. This still did not offer enough, he said. That is the reason the camp program has been pushed so strongly.

He called the program an "investment in the future." In the long run, he said, such a proved program would save money. He estimated costs to the state in annual support and to the community in loss of active contribution by a person sent to a penitentiary could amount to as much as \$8,000 a year.

He emphasized the importance of efforts at reformation to young people. "The hope for reformation is greater for youngsters than adults," he said.

Support Indicated

A question period followed the discussion by the four men, and most of those speaking indicated a strong support for the program. Several comments in favor of establishment of such a program drew applause.

The most persistent objection appeared to be the possibilities a delinquent might attend public schools. Helleck said a school

California Visitors Sample Buffalo During Local Visit

The flavor of the Old West—with some modern garnishment—was savored Thursday night at the Fairgrounds by 78 members of the "College of Fairs on Wheels."

The tour of two busloads of fair people from California, sponsored by the Western Fairs Association, en route to the Seattle World's Fair stopped overnight in Roseburg.

Greeted with Douglas County hospitality, the group was ushered into the Fairgrounds where the aroma of cooking meat wafted from a barbecue pit near the Community Building.

Zoo Provides Fare

The aroma was created by the Roseburg Lions Club grilling "buffalo-burgers" for the out-of-state visitors. Meat for the dinner, which was attended by the 78 and about 40 local people, was provided by the county's buffalo—a former star of the county zoo at the Fairgrounds.

One of the visitors, when hearing where the meat came from, praised the hospitality of the county by exclaiming that it had killed its "fatted buffalo just for us."

Actually, the job was done some months earlier when the zoo was disbanded. The Lions Club will use the rest of the meat to make "buffalo burgers" during the County Fair, Aug. 15-19.

Visitors from the Dixon, Calif., May Fair, said after the dinner that other host groups would have to go "a whale of a lot" to top the reception given the tour by Douglas County.

Entertainment Provided

Entertainment for the evening was provided by Earl Henbest's Indian dancers, the "Lancers," a trio from Roseburg High School; Parks Schneider with his "syncopated bones"; and Nell Molschenbacher and Helen Saar with a rendition of "Squads on the Umpqua" and "California Beatniks on the Umpqua."

Del McKay emceed the dinner and Commissioner Ray Doerner greeted the visitors. Gov. Mark O. Hatfield sent his regrets at not being able to attend but invited the group to stop at his office Monday on its return home.

The evening was concluded with slides shown by Louis Merrill, general manager of the Western Fairs Association. Overnight accommodations were made at the Umpqua Hotel.

Mad Mental Patient Slays VA Physician

PITTSBURGH (AP)—A crazed mental patient fatally shot a doctor at the Veterans' Administration Hospital today and wounded a policeman during a gunfight. Police stormed their way into an office where the patient had barricaded himself and found him wounded but alive.

Officers identified the physician as Dr. Daniel Thaw, chief of acute and intensive treatment at the VA Hospital at Leech Farm on Pittsburgh's Washington Boulevard.

Hospital officials said the patient is William S. Polla, 27, of Wilmerding, Pa.

Polla had holed up in a first-floor office of a hospital building. He held the doctor at gunpoint, apparently as a hostage at first. Scores of police sped to the scene and surrounded the building. An armored car was summoned. Tear gas grenades were fired.

Officers said Polla was armed with a .45 automatic, and possibly a second gun.

Hospital officials said Polla was discharged from the hospital last April 19 as a voluntary mental patient. He had been in and out of the hospital since the Korean War.

A nurse pleaded with the patient to give himself up, but he did not heed the pleas. The nurse, with Pittsburgh Police Supt. James Sussner at her side, also talked with the man later by phone and urged him to surrender.

The wounded officer was patrolman Horace McDaniels. He walked to an ambulance and was taken to a hospital.

McDaniels was hit during a brief exchange of gunfire with Polla.

Search Widens In Jungle Hunt

SAIGON, South Viet Nam (AP)—Teams of searchers roved the jungle 150 miles northeast of Saigon today in an effort to trace three American missionaries kidnapped Wednesday night from a leper camp by Communist guerrillas.

Among those on the scene was the Rev. Thomas G. Mangham, director of the Christian and Missionary Alliance in South Viet Nam which operated the camp.

Armed forces also were reported helping in the search.

A military source in Saigon said the U.S. Army special forces detachment stationed in Ban Me Thuot, eight miles from the leper camp, would not participate in the search unless asked.

The Rev. A. E. Mitchell of Ellensburg, Wash.; Daniel Gerber of Dalton, Ohio; and a woman, Dr. Eleanor A. Vieth of Houston, Tex., the Viet Cong guerrillas left Mitchell's wife and four children and four American woman nurses unmolested at the camp.

In overrunning the leper camp, the Communists seized large stocks of food and medicines. About 250 patients are under treatment there.

Third Round Butte Accident Victim Die

REDMOND, Ore. (AP)—Ollie Lewis, 28, Sandy, Ore., became the third victim of the May 13 construction accident at Round Butte Dam when he died Thursday at Central Oregon District Hospital.

Lewis was among a crew of eight men pouring concrete for walls of a spillway tunnel on the project 10 miles west of Madras when a cable anchor pin snapped and sent their 20-ton steel form plummeting 150 feet.

Ireneaux E. Ochs, 36, Terrebonne, Ore., and Robert Clinton, Bend, were killed in the plunge.

Eichmann Remains Defiant, Chides Guards As He Steps To Gallows; End Comes Fast

TEL AVIV, Israel (AP)—Defiant to the end, Adolf Eichmann walked firmly to the gallows Thursday night and paid with his life for his role in Nazi Germany's systematic extermination of 6 million European Jews.

The young state of Israel hanged the former Gestapo colonel at two minutes before midnight on an improvised scaffold in a third-story storeroom of Ramleh Prison near Tel Aviv.

It was the first execution in the 14-year history of this Jewish nation which counts among its citizens thousands of relatives of Jews whom Eichmann, 56, helped speed to death in Hitler's gas chambers.

Eichmann's body was cremated quickly and the ashes scattered upon the waters of the Mediterranean.

Eichmann was cool and unrepentant as this Jewish nation carried to conclusion its announced determination to record the history of the Nazi pogrom and mete out justice in the name of all Jews.

A faint smile on his face, Eichmann spurned the traditional black hood and even chided his jailers for making it difficult for him to stand on the gallows' trap door.

"My belief was correct," the former head of the Gestapo Jewish affairs section declared. "I had to obey the rules of war and my flag. I am ready."

At a command from an Israeli guard, Eichmann stepped to the trap door and lunged to his death almost in a single motion.

Death was instantaneous, prison officials said.

Eichmann was condemned to death last December by a special three-judge tribunal which found him guilty of acts of unparalleled enormity against the Jewish people and against humanity—the only crime subject to capital punishment in Israel.

Only Minor Cog

The building, bespectacled Hitler disciple had insisted he was only a minor cog carrying out orders from above in the Nazi campaign for "the final solution to the Jewish problem"—extermination.

But the court declared he actually relished shipping Jews to their deaths by the hundreds of thousands, saying he was motivated by "an ardent desire to blot out an entire people from the face of the earth."

The Israeli Supreme Court rejected Eichmann's appeal against the death sentence Tuesday, declaring even death was an inadequate penalty.

And with unexpected speed, President Izhak Ben-Zvi sealed Eichmann's doom about noon Thursday, rejecting appeals for executive clemency from Eichmann, members of his family and others.

Eichmann was transferred quickly from his cell in Jerusalem, where he had been lodged for the Supreme Court decision, to Ramleh Prison. There, his spiritual adviser, the Rev. William Hull, visited him in his cell.

Defiant At End

The Canada-born Protestant clergyman reported later that Eichmann was not sad but was defiant. Eichmann, who earlier had expressed a belief in God but belonged to no church, refused to reaffirm a faith in Christ.

"I do not have time to read the Bible," Eichmann told the minister. "I have peace in my heart. I am ready to die."

Eichmann was told of the rejection of the clemency appeals—but not that he was to die that night—about 8 p.m. He asked for and received a bottle of red wine. He drank half of it.

Outside a thick fog set in. Guards turned on flood lights and police set up roadblocks to divert traffic from the prison, a former British fort, on the Tel Aviv-Jerusalem road.

Made One Request

Eichmann learned death was at hand only when guards came to his cell to take him the 50 yards to the gallows. He walked steadily to the execution room handcuffed to two guards. He made only one request—to stop and blow his nose.

Dressed in brown slacks and a brown shirt open at the neck, he mounted the scaffold by a single step and stood directly under the noose which was suspended over his head on a chain. His hands and ankles were bound with white cloth.

As the noose was fitted over his head, Eichmann half closed his eyes and looked downward at the gallows. As the black hood was proffered, Eichmann said: "I don't need that."

Eichmann spoke his last words to a small group of officials, guards and newsmen gathered to witness the execution.

"My belief was correct," he said. "After a short while, gentlemen, we shall all meet again. So is the fate of all men. I have lived believing in God and I die believing in God."

"I Am Ready"

"Long live Germany. Long live Argentina. Long live Austria. These are the countries with which I have been most closely associated and I shall not forget them. I greet my wife, my family and my friends. I had to obey the rules of war and my flag. I am ready."

Eichmann, the father of four sons, was born in Austria, served Germany and hid out after World War II in Argentina.

Eichmann's wife, Vera, was the only member of his family to see him in prison.

Moments before Eichmann stepped Thursday night on the black square marking the trap door, a guard shouted, "Muehan"—the Hebrew word for ready—and Eichmann disappeared from view.

"Jesus, Jesus," repeated the Rev. Mr. Hull, the only clergyman present.

One man said he was in favor of such a camp but not in the Myrtle Creek area.

Speaking strongly in favor of the camp program were Ivan Edwards, Democratic candidate for county commissioner and Chief Robert Lewis, Roseburg Navy recruiter.

The most persistent objection appeared to be the possibilities a delinquent might attend public schools. Helleck said a school

would most likely be a part of the camp installation. However, in some cases it might be necessary to send a youth to a public school to allow him to graduate with his class.
