As this is written, the big political news is the unexpected defeat in the house of representatives of President Kennedy's GET TOUGH farm bill. In the final showdown, it lost by a vote of 215 to 205.

It had been passed by the senate, by a narrow margin. Its approval by the house had been rather confidently expected. The obvious conclusion is that at the last minute there was a lot of soul-searching by members of the house who will have to face the farm voters this fall.

It was a tough bill. It put teeth in proposals to cut down production at a time when the war-houses are bulging with surpluses.

It would have placed MANDATORY acreage reductions and national marketing quotas for the first time on feed grains and wheat. These grains have contributed most heavily to the massive surpluses now held by the government.

It carried an implied threat that if the farmers failed to go along with its provisions the accumulated surpluses might be thrown on the market for what they would bring. That was the mailed fist in the velvet glove.

The American Farm Bureau Federation, which led the fight against the bill, calls the house vote this morning a VICTORY for farmers, consumers and taxpayers, and adds: "The only losers were the political empire builders in Washington."

The interesting part of this "tough farm bill" proposal, from the beginning, was why the Kennedy administration would risk so tough a project. It was generally regarded as evidence that the New Frontiersmen, after analyzing the results of the 1960 election, had come to the conclusion that the balance of political power in the U.S.A. is now held by the tightly packed (and largely Democratic-voting) masses in the Big Towns and that it will now be safe to disregard the farm vote and rely for power on the big city vote that seems solidly Democratic and New Frontier minded.

The AFB's comment that "the only losers were the political empire builders in Washington" seems to go along with the new theory that the Democratic party's future lies wholly in the Big Towns and so the farmers can safely be told what they must do — or else!

A NEGATIVE CAMPAIGN

Our newspapers are full of confident statements from Republican political leaders. The G.O.P. to believe all one reads, will make substantial gains at this year's election. It wouldn't be at all surprising if the Republicans should show some results pleasing to the members of that party. It normally is true that the party in opposition to the administration makes gains in elections between presidential years. If the Republicans fail to pick up some congressional seats and, perhaps, some governorships, it would be surprising.

The "outs" have a big advantage over the "ins" when it comes to campaigning. The "outs" can always "view with alarm." They can find all manner of fault with the "ins." They can be "Monday morning quarterbacks," pointing out all the errors made by the "ins," telling the "fans" what should have been done.

But I believe the Republican Party, instead of being negative, and finding fault with everything the administration is doing, should give us a positive program.

It isn't enough when a candidate, in campaigning against the man in office, says: "I can do what he's doing, only better."

Perhaps the Republicans have some policies in mind to improve the country. If such policies have been announced in any specific terms, I've overlooked them. I've read some more or less high-sounding generalities, which, as one of the late Irvin Cobb's characters was wont to comment: "His mouth says words but they don't mean nothin'."

There is, in my opinion, a decided conservative swing. But we find a good many Republicans willing to join the left-wingers, if they can't beat 'em. Anything to get elected! It's my opinion that Republicans should stick with their conservative theories, maintain party principles. If sticking with principles means defeat, then take a licking.

But the G.O.P., in my opinion, should be positive, not simply a party of grippers.

FACE SAVING ANNOUNCEMENT

Edward Cliff, chief of the U.S. Forest Service, reportedly has advised some of our complaining senators that he is preparing to take steps to ease some of the timber management problems in the Pacific Northwest.

His proposals are important in that they will save face for some of these senators who, unquestionably, are on the hot seat.

These senators quite obviously are trying to escape from advocating the one thing that would give immediate relief to our timber industry. They seemingly will do most anything to keep from proposing amendment to the Jones Act. That would permit our lumber industry to compete with Canadian mills now taking over our market. But those same senators would run into opposition from transportation labor unions. The railroad brotherhoods and teamster unions are very powerful. They represent a lot of votes. Consequently our senators will be delighted to have a way out.

Cliff's proposals, needing several months to implement, would get us by the fall elections, whereupon the whole matter could be dropped.

And, at the same time, these same senators will be telling our woods and mill workers how diligently they are laboring to solve the industry's problems.

And, doubtless, some of our voters will be taken in by these claims of soltitude.

Watchdogging Uncle's \$\$\$ Is Too Much For Any Man

WASHINGTON — (NEA) — No body has the slightest idea of how much money is wasted away in handling the United States government's \$90 billion budget. If it is only one-tenth of 1 percent — one cent out of every \$10, which would be low in almost any business — it would still be \$90 million a year, an awful lot to lose down any rat hole.

There is some opinion that the sheer size of the government's defense, foreign aid, farm, highway, housing and other programs makes it impossible to run a tight fiscal control operation with every cent of the taxpayers' money accounted for.

Comptroller General Joseph Campbell, head of the General Accounting Office, which is the government's watchdog operation, doesn't believe size is the cause of government waste. He thinks it more a question of good or bad management in government agencies.

For the last several years he has been concentrating on improving government business techniques. Previously, one of his agency's principal functions was to rubber-stamp approval on vouchers submitted for audit.

In clearing transportation vouchers, for instance, GAO used to be 10 years behind. Now it's only six months.

Scotch Joe Campbell used to be treasurer of Columbia University. President Eisenhower brought him to Washington, first as a member of Atomic Energy Commission. ("No five-man commission can run any business," he says now.) Then he was named comptroller general in December, 1954, for a 15-year term.

He is responsible only to Congress, which makes him completely independent of the executive arm of government. But the waste of congressional junketing, payroll padding and hiring of relatives, the GAO can't touch. Nobody can, and this is one of the worst abuses in government.

Profile Of Patriotism

American patriotism is a topic that today frequently inflames the citizen's emotions and embroils him in controversy. To treat the subject calmly has become increasingly difficult.

A good many staunch conservatives dwell these days on strong assertions of patriotism. For their pains, they are sometimes denounced by others as "superpatriots."

Rep. William Widnall, New Jersey Republican, is just one of a substantial number of people who are complaining at this kind of designation. He writes in his newsletter:

"You have heard patriotism decried and called outmoded. If one speaks of a rebirth in America of patriotism, loyalty and rededication to the principles of freedom and liberty, he is ridiculed for waving the flag."

Now, of course, patriotism is never going to be outmoded. Nor should it need a rebirth, unless all signs are wrong.

For the dictionary defines patriotism very simply as "love of country, devotion to the welfare of one's country." And there cannot be very many among the nation's 185 million who do not feel that sense of devotion.

We have our avowed or secret Communists, no a large number by J. Edgar Hoover's testimony. There are probably more than a few Americans who actively dislike their country without having the slightest interest in communism or any other foreign ideology. And undoubtedly we have some who are just indifferent.

No one could take a census of these latter categories, but it would be a surprise if they bulk very large.

So, assuredly, most American are patriots. And there can be nothing wrong in their asserting love of this country. Quite the contrary.

But those who frequently or constantly assert their patriotism are not by that fact automatically superior to those who do not. The test of the patriot is in the doing. How do you show your love of this country?

Widnall wisely suggests that effective patriotism spells hard work, assumption of responsibilities, a rising to the challenges we face individually and as a nation.

We Americans are an open-hearted, cheerful, inventive and industrious people. We are enormously blessed with riches and the space in which to use them. We live under remarkable economic and political freedoms.

To all these things we can and should be deeply devoted. But patriotism is something felt individually as well as collectively. Patriotism is a vessel each man fills in his own special fashion.

Oregon Drivers Said Worst Driving Offenders

I am an Oregonian, born at Walker, Oregon, 1901, and have lived in western Oregon nearly all my life. I have lived in Douglas County over 24 years; I started driving a car when I was 12 years old. In those days if you were big enough to crank a Model T Ford you were big enough to drive.

As to your editorial of June 15 on "Signs Inadequate," I have noticed through my years of driving that, regardless of how many or how few road signs there are, far more cars with Oregon license plates take chances than out-of-state cars.

Through conditions, not by choice I have to drive an older model car. I keep it in good shape and put it through any safety test. Most of the close calls I have had, which were many, resulted because someone with a later car than mine couldn't stand to remain behind an older car. Such drivers will pass on blind curves and without enough visible clearance. Then they'll slow down to normal speed after passing.

I drive between 50 and 60 miles per hour when on open road. In your editorial of May 15 you spoke of the low price of fishing license. After hunting for information, I have found only eight states with a higher license than Oregon's. One state has the same. All the rest are lower. (Most of them much lower.)

Since starting to work for wages I have spent most of the time in sawmills. Because of a handicap from childhood I was not able to work in the woods.

At present I am on a small disability pension, which my wife and I must live on. I had looked forward to the time when I could get a pioneer hunting and fishing license. When I reached the age of 60 I found the State Game Commission had set a deadline for pioneer licenses, and I was born too late. I have purchased a hunting and fishing license nearly every year since I was 18.
