

Sen. Neuberger Seeks Timber Curb On Canada Imports

WASHINGTON (UPI) — Sen. Maurice B. Neuberger, D-Ore., has called for changes in U.S. shipping laws to help cut back a record flow of Canadian softwood lumber to U. S. Atlantic Coast markets.

Mrs. Neuberger told the Senate that reductions in foreign charter shipping rates carrying British Columbia lumber had given Canadian lumbermen an added edge over U.S. lumbermen.

U.S. lumber mills which send their product to the East Coast by sea must use American-flag vessels because of U.S. merchant marine laws. Mrs. Neuberger said U.S. rates had remained unchanged while foreign charter rates had dropped.

Mrs. Neuberger has introduced a bill to allow West Coast lumbermen to use foreign vessels for shipments to the East Coast. A similar bill died without coming to a vote in the last Congress, although a measure was passed permitting U.S. lumber to be shipped to Puerto Rico in foreign vessels.

Plaintiff asks custody of their four minor children and that support be held in abeyance until plaintiff is again able to work. She asks award of equity in real property located in Lot 35, Melrose Orchards, and household furnishings. On motion and affidavit of plaintiff, defendant ordered to move from the premises now occupied by him and plaintiff, and restraining him from interfering with or molesting plaintiff. Show cause order issued for defendant to appear June 10 as to why order should not be made permanent.

Thelma vs. Ehrman Smiel. Answer and cross complaint of defendant. Married May 8, 1948. Defendant charges cruelty. Defendant asks custody of minor child, that real property listed as Lot 1, Block 1, Two Oaks Tract, Winston, be sold and proceeds divided. He asks award of 1955 car, and that furnishings and fixtures of home go to plaintiff.

Arlene vs. Robert Harold Winders. Married Feb. 23, 1962, at Reedsport. Cruelty charged. Plaintiff asks custody of minor child, \$50 monthly support and award of household furniture. On her motion and affidavit, court order issued restraining defendant from assaulting, molesting, threatening or in any manner interfering with the liberty of plaintiff or the minor child. Plaintiff granted temporary child custody, and defendant or others claiming child required to return the child to the plaintiff until further court order, June 17 set for cause why he should not be required to pay attorney fees and child support.

Nora L. vs. Hershel B. Killian. Married March 27, 1946, in Hugo, Okla. Plaintiff asks custody of two minor children and \$50 monthly support for each. Cruelty charged. Plaintiff asks that defendant be awarded their equity in real property consisting of 80 acres, being purchased on land sale contract, located in the Sutherland Land and Water Co. tract. Plaintiff asks award of 1959 automobile and listed household furnishings, with award of 1956 pickup, farm tractor and attachments to defendant.
