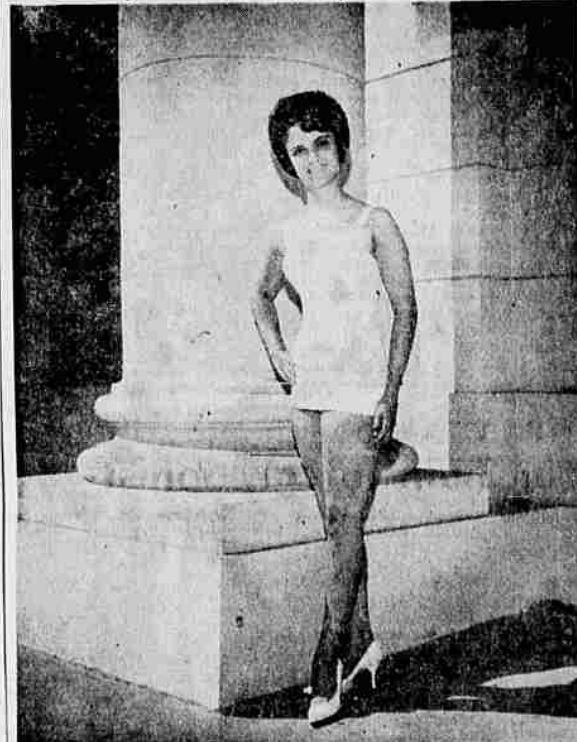

# Big Unions Increase Pressure As Lumber Strike Hits Montana

PORTLAND (UPI)—The Pacific Northwest's big lumber unions moved on two fronts Thursday to put more pressure on the "Big Six" wood products manufacturers.

A strike against St. Regis Paper Co. spread to Montana with the announcement that 1,000 members of the Lumber and Sawmill Workers Union (LSW) would walk off their jobs at St. Regis operations in Libby and Troy, Mont., today.

The action was announced by Earl Hartley, executive secretary of the union's Western Regional Council.

The LSW and the International Woodworkers of America struck St. Regis and U.S. Plywood 10 days ago after contract talks broke down. The four other members of the "Big Six," Weyerhaeuser, International Paper, Rayonier and Crown Zellerbach, then shut down in retaliation, claiming a strike against one was a strike against all.

The IWA announced Thursday it had filed charges of unfair labor practices against all six firms. Western Regional President Harvey Nelson said the complaint charges the companies conspired to close their operations by locking out union members illegally. Complaints were filed here and in Seattle.

Nelson said the four which shut down after the strike started sent letters to union locals which said the closure was designed "to preserve the integrity of the association." The union official noted that U.S. Plywood-owned or operated plants at Gold Beach and Cottage Grove, Ore., and Eureka, Calif., which employ non-union help, have remained open.

## 'Bama Campus Nearly Normal

TUSCALOOSA, Ala. (UPI)—The University of Alabama campus had a look of normalcy today with only the scattered presence of police and soldiers spoiling the effect.

The officers and National Guardsmen are insuring the safety of two Negro students admitted to the former all-white institution under federal court order Tuesday.

The Negroes, Vivian Malone and James Hood, attended their second day of classes without incident Thursday. They have been met with some friendliness, but white students generally have paid little attention to them.

A third Negro, David McGlathery, entered the university's extension center at Huntsville Thursday and virtually was ignored by students on the 330-acre campus.

A dozen helmeted police officers observed McGlathery's admission to the Huntsville school. McGlathery, a 27-year-old mathematician at the Marshall Space Flight Center, signed up for graduate study in math. He was enrolled under the same order that forced the Negroes' admission to the main campus at Tuscaloosa.

McGlathery said his peaceful registration "speaks good of Huntsville, of Alabama and the country as a whole." He attended his first class Thursday night and described it as "rough."

Army Secretary Cyrus Vance in Washington Thursday authorized Alabama guardsmen, federalized by President Kennedy Tuesday, to return to their civilian jobs unless they were in summer training or part of the 1,200 guardsmen here.

## Tennessee Boy, 13, Is Spelling Champ

WASHINGTON (UPI) — Glen Van Slyke III, the spelling champion from Oak Ridge, Tenn., enjoyed his hard-won victory today and forgot about words like "agiotage," "antimacassar" and "exubiate."

These were some of the tough ones through which he carefully worked his way Thursday to win the 30th annual national spelling bee.

Glen, 13, is a deliberate young man who shows his experience as a speller. But so did the black-haired miss who battled him down to the finish line, Elaine Piecuch, 14, of Winslow, Maine.

The two failed on "tarboosh," "skase," and "marchioness" before Glen finally pulled ahead by spelling "billionness," which Elaine missed. Then he spelled "equipage" to win the title.

In so doing he also won \$1,000, a weekend trip to New York City, a trophy cup, a plaque for Robertsville Junior High School of Oak Ridge and a ruby-set gold medal.

Elaine won \$500 and a plain gold medal. She has been attending St. John the Baptist School in Winslow.

A third prize of \$250 went to Gary Barringer, 14, of East Liverpool, Ohio. The next five contestants won \$100 prizes. They were Christine Dickson, 14, Aiken, S.C.; Debara Carbaugh, 12, Denver, Colo.; Alan Simmons, 13, Huntington, W.Va.; Danny Luce, 14, Youngstown, Ohio, and Louis McIntosh, 12, Dover, N.H.
