

Pope Paul Calls For World Peace

Ecumenical Council Will Be Continued

VATICAN CITY (UPI) — Pope Paul VI said today his pontificate will be dedicated to a continuation of the unifying ideals of the Ecumenical Council and peaceful preservation of world order.

The 65-year-old pontiff made the inaugural speech of his reign in Latin before cardinals of the Roman Catholic Church gathered in the ornate Sistine Chapel where he was elected Friday as the 262nd successor to the throne of St. Peter.

"The prominent part of our pontificate will be concerned with the continuation of the Ecumenical Council Vatican II," he said.

"This will be the principal work for which we intend to spend all our energies which the Lord has given us."

The council, called by the late Pope John XXIII, was automatically suspended with his death on June 3.

It was to have resumed Sept. 8, but Pope Paul did not set a date for the second session in his speech this morning.

Social Justice Important
The preservation of order and social justice in the expanding space age also is of paramount importance, the pontiff said.

"The unequivocal order of love for the neighbor, testing bench of the love for God, requires from all men a more equitable solution of social problems," he said.

"It demands assistance and help for the underdeveloped countries, where the living standard often is not worthy of human persons. It imposes a zealous study on a world scale for an improvement of living standards."

The new era, which space conquests have opened up for mankind, will be singularly blessed by the Lord if men will really know how to recognize one another as brothers, rather than as competitors and build the order of the world on the holy fear of God, in respect for His law in the steady light of charity and mutual collaboration."

Pope Paul said he would use every effort for world peace.

"With the help of God, (we) will spend every effort for the preservation of the great asset of peace among the nations—a peace which is not only absence of warlike rivalries or of armed factions, but a reflection of the order wanted by God the creator and redeemer, a constructive and of brotherhood, unshakable display of good will, unimpaired desire of working concord, inspired by the true good of mankind with unfeigned charity," he said.

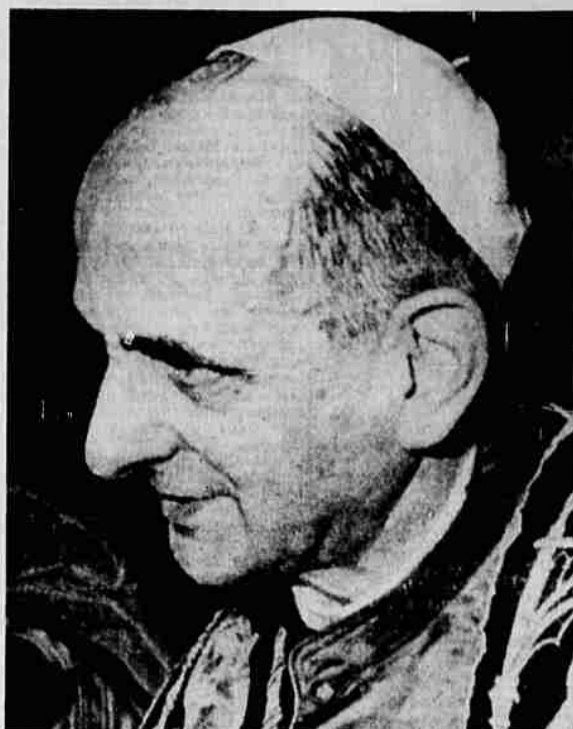
Speaks With Each Cardinal
Pope Paul spoke after each of the 79 cardinals who attended the conclave which elected him pontiff paid their respects and pledged obedience to him in ceremonies inside the Sistine Chapel.

The cardinals walked the length of the chapel with slow, measured steps, before kneeling in front of Paul VI, who was seated on a throne in front of the main altar.

They kissed his ring and the Pope kissed each, speaking at length with each. The cardinals and the Pope, almost without exception, were smiling and the conversations were animated.

Pope Paul will be formally crowned with the gold and jewel encrusted triple crown at ceremonies in St. Peter's Basilica June 30. Later he will grant his first private audience to a visiting chief of state—President Kennedy.

SCHWEITZER HEADS FUND

Pilot Survives 2.8-Mile Drop As Chute Fails

LONG BEACH, Calif. (UPI) — "This business of your whole life flashing before you is baloney, at least in my case. I was too busy for that."

That did Marine 1st Lt. Cliff J. Judkins III describe his reaction to plunging 15,000 feet and landing—feet first—in the ocean when his parachute failed to open after he bailed out of his disabled jet fighter.

The 26-year-old Allanta, Ga., pilot Friday said that he almost didn't get out of his F8 Crusader jet because his ejection apparatus would not work after he discovered something went wrong with the plane.

Speaking from the hospital ship Haven, Judkins said at first he was afraid to go over the side for fear of hitting the tail.

"I was thinking to myself, what a helluva way to die, watching it come up at you, when Bill (1st Lt. Bill Waters, wingman in the formation) hollered to get out any way I could."

Judkins said he narrowly missed the tail, but fell free—only to find his main chute would not open.

"The rest of the way down I was shaking hell out of the chute trying to get it to open."

The flying Leatherneck said he saw an oil slick where his plane hit the water. He hit the water—feet first—100 feet away.

"It didn't hurt then, although I figured my back was broken. I could tell my ankles were broken from the way my feet flapped around."

Judkins spent 2½ hours in the water before he was rescued by a Navy ship. He subsequently was transferred to a hospital ship and brought here.

Attendants said Judkins received a compressed back fracture, a hairline fracture of his pelvis and two broken ankles in the accident last Wednesday over

the Pacific Ocean about 800 miles from shore.

Judkins' condition originally was listed as critical, but he now was reported much improved.

His was one of the few cases on record in which a man has fallen from such a height and landed in the ocean—and survived. Navy medical records indicated.

Mac Faces More Woes

LONDON (UPI) — Rumors that more cabinet ministers may be involved in Britain's "scandal of the century" hinted today at the possibility of additional trouble for Prime Minister Harold Macmillan's beleaguered government.

Opposition sources said the Labor party may try to force Macmillan to broaden his investigation into the case involving former War Minister John Profumo, recalled Soviet naval attaché Eugene Ivanov and their mutual friend, red-haired Christine Keeler.

Friday Macmillan himself acknowledged the whispers sweeping London when he told the House of Commons that "terrible rumors" were circulating about ministers other than Profumo.

Profumo resigned from office after admitting he lied when he informed the house that there had been nothing improper in his relationship with the attractive playgirl.

The security threat implicit by Ivanov's involvement in the case shook the Macmillan government. The Conservative party already had been staggering under a series of special-election defeats.

Macmillan announced he had appointed Lord Denning, a twice-married judge and master of the roils, to lead a judicial inquiry into the security aspects of the affair.

But Labor party Leader Harold Wilson accused the government of "running away from the truth."

He called such an inquiry "totally inadequate to allay public anxiety" and said it could lead to a "bigger and vaster cover-up than we have had."

There have been allegations that attempts were made to get the Keeler girl to pry official secrets out of Profumo, but without success.

The Labor party's "shadow cabinet" meets on Monday. Sources said it may force a house debate on whether to set up a parliamentary "select committee" armed with the right to subpoena witnesses and documents. Denning will not have this power.

Jupiter Pluvius Dumps Heavy Rains On County

Loggers and gardeners are smiling — farmers are frowning. Mixed emotions were evident in Douglas County at last night's 75 inches of rainfall, most of which fell between 11 p.m. and 1 a.m.

Actually, the rain is not unusual, says the weatherman. Normal for the month is 1.5 inches. It's not usually dumped all at once, though, as it was last night.

Unless something unusual happens in the weather line, the normal 1.5 will prevail again this month. Light rains will probably make up the 6 inches needed to bring it up to that average.

Space Couple Gets Heroes' Welcome In Moscow

Soviet Fliers Receive Buss From Khrush

MOSCOW (UPI) — Cosmonaut Valentina Tereshkova and cosmonaut Valery F. Bykovsky arrived here for a hero's welcome today and got the traditional bear-hug and kiss on each cheek from Premier Nikita Khrushchev.

Valentina, who soared to fame last Sunday as history's first woman in space, was so overcome by the pomp and ceremony she promptly forgot her formal report to the Soviet leader.

The 26-year-old parachute enthusiast, decked out in a severely cut black suit and white high-heeled shoes, paused for a good 10 seconds in the middle of her report on the success of her mission aboard the spaceship Vostok VI. Then she found her place and finished.

From the moment Valentina and Valery, who holds all records for manned space flight with 81 orbits aboard Vostok V, arrived aboard a special jet-escorted airliner, little things seemed to go wrong.

First, they got out of step as they descended the ramp of their airliner and Valentina had to skip a step to get back in time with Valery.

Valentina, a brunette whose code name in space was "Seagull," smiled as she and her space-brother walked the almost 100 yards of red carpet leading to where Khrushchev and other dignitaries were waiting to greet the two. But she obviously was nervous.

Thousands of Muscovites turned out at Moscow's Vnukovo Airport for the arrival, and they seemed almost as moved as their two new heroes.

Bykovsky, looking smart in his uniform of a lieutenant colonel in the Soviet air force, saluted Khrushchev and then began his report. He stumbled in two places, but managed to get through it.

The crowd seemed to hold its breath as Valentina began her report. She stopped in the middle, groped for words, remembered them again, and finally finished.

Although Khrushchev sedately kept his embrace for Miss Tereshkova to kisses on each cheek, he smacked Bykovsky right on the lips in the traditional Russian fashion.

Hundreds of thousands of Soviet citizens lined the route all the way from the airport, and thousands more jammed Red Square itself. The open car carrying the two heroes and Khrushchev was covered with so many flowers it looked like a rolling bouquet.

As any girl would on such an occasion, Valentina apparently spent a lot of time getting her hair to look just right. She is known to have gotten a new hairdo just two days before she went into space.

Alternate Route Told For Diamond Lake Trip

JFK Starts Europe Trip Later Today

WASHINGTON (UPI) — President Kennedy sets out tonight on the longest foreign tour since he entered the White House—a venture in personal diplomacy in West Germany, Great Britain, Italy, and Ireland.

The Chief Executive was scheduled to take off from Andrews Air Force Base tonight for Bonn, capital of the West German republic in which he will spend three days conferring with Chancellor Konrad Adenauer and other officials. Kennedy will wind up Wednesday with a visit to the Berlin wall.

Before departing for Europe the President had a full day at home beginning with a morning White House conference with 29 civil rights leaders.

Plans Camp Visit
After this meeting, Kennedy planned to fly by helicopter to Camp David, Md., to spend the afternoon with his wife and two children. He will rejoin his family on Cape Cod when he returns to the United States July 3.

Tonight the President will fly directly from Camp David to Andrews Air Force Base to take off on his transatlantic flight aboard Air Force 1, the large jet-fan transport assigned to his use.

One of the curious and difficult aspects of the President's trip is that he will not visit a country where the government is without political troubles.

In West Germany, the Adenauer government is on the way out and Kennedy will devote some time with the aged chancellor's expected successor, Dr. Ludwig Erhard, vice chancellor and minister of economic affairs.

Government Formed Friday
In Italy, a new government was formed only Friday, after a 36-day search for a successor to former Premier Amintore Fanfani.

In Great Britain, Prime Minister Harold Macmillan is believed to be on the way out because of the recent Profumo scandal.

And even in Ireland, where Kennedy's visit was originally supposed to be little more than sentimental and ceremonial, the government of Premier Sean Lemass is in political danger because of an internal fight over budgetary matters.

One thing seems solid about the trip—Pope Paul VI will be crowned on June 30, the day Kennedy arrives in Italy.

The Chief Executive, after conferences with Italian officials, will go to Vatican City July 2 for an audience with the new pontiff before taking off the same day on his return to the United States.

Oregon Prison Escapee Taken By City Police

A 34-year-old escapee from the Oregon State Prison annex was arrested by Roseburg City Police early Friday night.

Ellis B. Thompson told city police officers he had walked away from the minimum security annex about a mile from the prison last Saturday, police reports said. They said Thompson told them he had been in a prison since last October on a conviction for passing bad checks.

Thompson was arrested by officer Glen Cutler after he and Detective Sgt. E. R. Woodworth had been called by a Roseburg merchant who complained Thompson had passed a no account check at his store earlier in the day. Cutler made the arrest on SE Jackson Street in the downtown area about 5:40 p.m.

After being questioned at the city police headquarters about passing two checks in Roseburg Friday, Thompson admitted being an escapee from the state prison annex. He was returned to Salem Friday night by officers from the state prison.

Man Freed From Life Sentence Once Caused Stir In Douglas

William F. Cory, a man who caused a great stir in Douglas County more than a decade ago when he was charged with kidnaping an attorney's wife, is back in the news today.

He was freed this week from a Bremerton, Wash., jail after the Washington State Supreme Court ruled that Cory's life sentence for being an habitual criminal should be set aside.

The court decided that the charges would be dropped because private talks between Cory and his lawyer, Fred B. Cohen, had been secretly overheard and recorded by sheriff's deputies at the Kilsap County Jail, making the entire proceedings against Cory void.

In 1953, Cory was arrested in Medford and was charged with kidnaping Mrs. William Jones, the wife of an attorney who was defending him against a burglary charge.

At that time, he was charged with kidnaping, armed robbery, assault while armed with a gun, being an ex-convict in possession of a firearm and petty larceny. All the charges were dropped except the one of being an ex-convict in possession of a firearm.

Four persons died and two others were injured in a violent two-car collision on a rain-slickened highway north of Independence Friday night. In addition, a single car crash killed a Heppner man today and a Portland woman died as a result of a crash June 6.

The fatalities brought the state's death toll for Friday and today to eight.

Leonard Eldon Wise, 27, Heppner, was killed early today when his car failed to negotiate a curve near Echo and sailed off the road.

A passenger, Lucille Judy Privett, 25, also Heppner, suffered injuries.

Mrs. Laura Weidmann, 80, Portland, died Friday from injuries she suffered in a June 6 crash. She was the second victim of the accident. Mrs. Clara Kezar, 72, the driver, died last Monday.

Victims in the Independence crash were Mrs. Doris Colgan, 49, of Monmouth; Esther Sandoval, 17, and Rose Sandoval, 16, Independence, and Sadie Peden, 16, of Independence.

Injured were Marie Eleanor Sandoval and Patricia Lee Elliott of Independence. Salem Memorial Hospital attendants said they suffered only abrasions and bruises.

Police said they did not know what caused the accident. Mrs. Colgan died in a Salem hospital. The bodies of the Sandoval girls were found in the wreckage and the Peden girl was discovered later after survivors told police there was another passenger in the car.

Two Dead
Two Lane County residents also died in separate accidents Friday. Mrs. Willoughby Blowers, 55, Creswell, was killed in a one-car accident on State Highway 226 four miles north of Cottage Grove. She was a passenger in a car driven by her son, Laverne, 23, which ran off the rain-slickened highway and hit a tree. He and another son, Stephen, 18, also a passenger, were not injured.

Mrs. Blowers was thrown from the car and crushed.

Mrs. Willam Cartwright, 19, Harrisburg, died in a Eugene hospital from injuries suffered in a one-car crash Tuesday.

Her vehicle left a road and slammed into a tree four miles north of Coburg.

Margot, the 17-year-old daughter of former Venezuelan President Marcos Perez Jimenez, and Lee Brook, 20, applied for the license with the blessings of the girl's family.

A family spokesman said Perez, who has been in the county jail since December while attorneys fight attempts to extradite him to his homeland on charges of looting the treasury, had resigned himself to the romance.

But when the couple vanished from the heavily guarded Perez mansion Tuesday night, the angry Perez used attorneys and private investigators to track down the lovers.

The runaway couple was located when Margot, after staying cooped up in a motel room with Brook for 48 hours, stepped outside for a breath of air and was recognized by Lily Steinfeld, wife of the motel manager.
