### Economic Indicators Show A Healthy State Of Affairs

WASHINGTON (UPI) — Two basic indicators of U.S. economic health showed improvement today with government reports that employment and industrial production continued to increase in July.

The Federal Reserve Board Thursday said that industrial production had risen one per cent over the June figure despite a 5 per cent decline in iron and steel manufacturing in July.

Employment outside of farm workers also continued its six-month increase during July, with a 56.8 million persons holding jobs, the Labor Department reported Thursday.

Unemployment remained about the same, Robert J. Stein, chief of the department's Division of Employment and Unemployment Analysis said, chiefly because the labor force increased at about the same rate as new jobs became available.

The department reported that manufacturing payrolls declined seasonally by 70,000 to a total of 16.9 million persons with the drop centered in the durable goods sector, particularly in the major metals industry.

### Nursing Home Ousts Elders

MONMOUTH (UPI) — Fourteen elderly persons were moved from the Madonna Nursing Home here Thursday because the owners of the home said they couldn't afford to keep them.

Mr. and Mrs. K. E. Draheim complained to the Polk County Welfare Commission that allowances for the recipients were not sufficient to run the home.

The fourteen, aged 77 to 95, were moved to homes at Dallas and Independence.

"We could keep them on the \$101 to \$174 a month we get," Mrs. Draheim said. "We could keep them like you wouldn't keep a dog."

She said the welfare commission had "downgraded the care allowance so much that we just can't keep them."

Mrs. Ruth Hardy, director of the Polk County Welfare Dept., said the complaint of not enough money is common among operators of nursing homes in the county, but this was the first time the department had been asked to move the patients.

Mrs. Hardy said downgrading of patients as they recover from hospitalization and require less care has been tightening recently due to closer scrutiny.

Rates for nursing home patients were raised \$5 monthly in the 1963 Legislature, but Mrs. Draheim said the increase has been more than offset by the more rigorous downgrading of patient ratings.

### Supreme Court Affirms Judge

The Oregon Supreme Court has affirmed Circuit Court Judge Don H. Sanders in the case of Robert E. Merritt vs. the State Industrial Accident Commission of Oregon.

The commission had appealed the verdict of the lower court in which a jury trial awarded Merritt compensation for permanent and total disability for accidental injury. The trial took place Nov. 28, 1962.

Merritt was injured March 13, 1961 while working for Bangs and Diek Logging Co. on a logging show on Smith River. He alleged he suffered a heart attack when required to climb up and down hills terrain as a choker setter.

The high court found no error in the trial as alleged by the SIAAC. The case was remanded to the lower court to enter judgment in accordance.

### 40,000 Turn Out For Big Crusade

LOS ANGELES (UPI) — Nearly 40,000 persons turned out Thursday night for the opening of evangelist Billy Graham's 25-day crusade here. He pinpointed this city as a potential leader of a "great spiritual awakening" in the United States.

Graham told the crowd that the entire human race has a sword of Damocles hanging by a hair over its head.

"Sooner or later," he said, "a crisis far worse than Cuba will put us all to sterner tests than Americans have ever endured."

"The racial crisis in America is getting bigger. Our debts are getting bigger. In foreign affairs, we are facing the awesome and growing power of Communist China."

### Meredith Calls Graduation Milestone In Racial Fight

JACKSON, Miss. (UPI) — To James H. Meredith, a 30-year-old Negro, graduation Sunday from the University of Mississippi is "but a single milestone" in a long task of advancing the status of his people in America.

Meredith collected his cap and gown this week even before the state college board cleared the way for his participation in commencement exercises at Ole Miss. He took his final exams Wednesday and then returned to his home in Jackson to await the ceremonies.

Upstairs in his apartment in a red brick building surrounded by old wooden Negro homes, Meredith's wife, Mary Jane, was in bed recovering from an operation. On the week-end of his graduation, Meredith was having to pinch-hit as a baby sitter for their 3-year-old son, John Howard, and pick up the groceries.

The Negro whose entry into Ole Miss was accomplished by the use of hundreds of federal marshals and up to 30,000 army troops told a reporter he hopes to go "three or four years more to college but he wants to do it in Europe. England is his choice."

"I want to study law or political science," he said in an interview.

Behind him were months of loneliness as the only Negro student at Ole Miss, the taunts of white students who were against him and the harassment of cherry bombs exploding in his dormitory; also memories of the first night of Sept. 30, 1962 when two persons were killed during rioting following his arrival on the campus.

"I've given many reasons why I went to the university," Meredith said. "Now it's been done, and I really know why I went. It was part of a bigger thing... to make it a fact that any citizen can get what is offered by the state to any other citizen."

"This doesn't mean that everybody has to do it. But it should be established that it can be done. I didn't gain the right last October. I always had the right. But that right had to be established."
