CIRCUIT COURT

Complaint

R. J. Miller vs. Paul Pullman, dba M & P Appliance and Refrigeration. Plaintiff states that prior to Oct. 12, 1961, he and defendant were partners in M & P Appliance and Refrigeration Service, but after the partnership was dissolved defendant agreed to collect accounts receivable and remit to plaintiff 50 per cent of the collection. He asks for a decree directing defendant to account to plaintiff for the sum of \$432.77 and to deliver to plaintiff this amount, and that plaintiff be awarded attorney fees.

Viola Coder vs. State Industrial Commission. Plaintiff asks that her case be remanded to the defendant and that she be allowed a claim for permanent partial disability equal to 95 per cent loss of function of an arm for un-scheduled disability, or such other disability as her condition would warrant. Injuries allegedly suffered July 17, 1960, while she was employed by the Beem Corporation as maintenance personnel at Cavalier Lodge. She claimed that while she was pushing a laundry cart she slipped and the cart rolled backwards, injuring her back.

Lloyd A. Wilson vs. Eugene H. and Lola B. Shockey. Plaintiff demands judgment for \$2,500 plus interest, attorney fees and costs, and foreclosure against defendant's interest, lien and equity of redemption on mortgaged personal property consisting of 100 head of sheep, together with any increase.
