

FBI Moved Quickly To Clear Up Case

The FBI also had serial numbers of most of the ransom money and was reported to have treated some of it chemically.
Irwin was the first suspect to be seized. He was picked up at Imperial Beach, Calif., at 9 a.m. PST (noon EST) Friday even as FBI agents in Los Angeles were hinting of an impending break in the case.
Arrested and Jailed
The painter, who had \$74,938

of the ransom money with him, was arraigned and jailed in San Diego in lieu of \$50,000 bail.
Keenan, 23, a crewcut blond, was arrested shortly before 11 p.m. ST (2 a.m. EST) at La Canada, Calif., a Los Angeles area community. He graduated from the same high school as Nancy Sinatra.
Amsler, 23, was arrested in Culver City, a community completely surrounded by the City of Los Angeles. Most of the ransom money was located in the apartment where he was arrested.

Keenan and Amsler arrived at the Los Angeles FBI office shortly after their arrests in a car driven by William G. Simons, special agent in charge.
Resembling calm college students, the pair were hustled into the office in handcuffs. About two hours later they emerged separately, still appearing untruffled and calm, and were taken to the federal building for arraignment.
Waive Hearing
Both waived preliminary hearing at the arraignment. After setting the \$50,000 bail, U.S. Commissioner Theodore H. Hoche turned to Keenan and said:
"Do you think your parents will be able to post bail?"
Keenan answered:
"I don't think my parents would be interested."
Amsler's barely audible reply to the same question was, "they can't afford it and I don't think they would be interested and I don't blame them."
All three have police records, but none had ever been charged with a serious crime.
Simons, who cautioned newsmen against questioning Keenan and Amsler as the two were first taken to the FBI office, said he would have no comment until later.
He would give no details of the arrests or say how the FBI traced the suspects.

\$57,122 Paid By Two Firms For Timber

Two companies paid \$57,122.10 for 2,339,000 board feet of Bureau of Land Management-administered timber in three sales at the district office at Roseburg.
The tracts contain 36 per cent salvage timber caused by the Columbus Day 1962 and subsequent windstorms. The timber on two other tracts received no bid and will be held open for a period of 90 days during which time bids for not less than the appraised price will be received.
Roseburg Lumber Co. of Dillard purchased the first parcel for \$18,885.30, with a bid of \$28.50 per thousand for Douglas fir and the appraised \$8.70 per thousand for western red cedar, \$11.10 per thousand for grand fir and \$10.30 per thousand for incense cedar.
Total volume is 743,000 board feet. It is located on Cam's Mountain. Other qualifying bidders were Skeels Logging Co. of Roseburg, Round Prairie Lumber Co. of Myrtle Creek and C&D Lumber Co. of Riddle.
The timber from the other two parcels was purchased by Woolley Logging Co. of Drain for the appraised price, with no other qualifying bidders.
One tract containing 1,304,000 board feet drew bids of \$24 per thousand for Douglas fir, \$7 for western red cedar and \$5.45 per thousand for white fir. On the other tract the appraised prices of \$27.20 for Douglas fir, \$9.80 for white fir, \$15.75 for western hemlock and \$11.55 for western red cedar were paid.
Both parcels are located southwest of Drain.

Freedom Due Man After Six Decades
CHESTER, Ill. (UPI) — The last time Richard Honeck spent Christmas outside prison walls he was 20 years old and William McKinley was President of a nation straining to start a new century.
Horatio Alger novels, with their young heroes making quick fortunes by honesty and hard work, were the literary rage.
But Honeck never saw the birth of the 20th century as a free man. He was sentenced to life imprisonment at Menard Prison here on Nov. 17, 1899, for the murder of his former school teacher.
Friday the Illinois pardon and parole board gave Honeck, 84, the news that surpasses the ending of any Horatio Alger novel: He might be freed from prison before Christmas, after spending 64 years behind bars.
For Honeck, one of 11 children of a Hermann, Mo., blacksmith, the news couldn't have been better. "I'm ready to go," he said when Warden Ross V. Randolph told him of the parole board's decision.
Randolph said the one thing on the prisoner's mind when he

U. S. Resumes Relations With Honduras, Dominica

WASHINGTON (UPI) — The United States today formally resumed diplomatic relations with Honduras and the Dominican Republic. Recognition had been withdrawn after military coups in both countries.
The State Department announced that diplomatic notes were sent today formally recognizing the governments which came to power following a military coup in Honduras Oct. 3 and a similar coup in the Dominican Republic Sept. 25.
U.S. officials said, however, that no decision has yet been made on resuming aid to the two countries, to return economic or military aid missions or to return U.S. ambassadors. All were withdrawn following the coups.
Officials said these additional steps would be considered later. They indicated they would depend on continued progress of regimes in the two countries toward return to democratic, constitutional government.
The State Department announcement said the recognition action was based on the fact that both the Dominican and Honduran regimes have issued decrees setting forth timetables for free elections.
"Both regimes have given public assurances of respect for civil liberties, freedom of action for political parties, and that international obligations will be fulfilled," the U.S. statement said.
The U.S. embassies in the two countries, were not closed down when the American ambassadors were withdrawn. They are presently headed by charges d'affaires.
In suspending relations following the coups which ousted President Juan Bosch of the Dominican Republic and President Ramon Villeda Morales of Honduras, the Kennedy administration said the freeze could be lifted if the rebel regimes took concrete steps toward restoration of democracy.
U.S. officials believe this requirement has been met in Honduras. Military leaders there have agreed to turn over all power in March, 1965, to a

constituent assembly which would draft a constitution. A new president would then be elected.

U. S. Resumes Relations With Honduras, Dominica

WASHINGTON (UPI) — The United States today formally resumed diplomatic relations with Honduras and the Dominican Republic. Recognition had been withdrawn after military coups in both countries.
The State Department announced that diplomatic notes were sent today formally recognizing the governments which came to power following a military coup in Honduras Oct. 3 and a similar coup in the Dominican Republic Sept. 25.

Ex-Con Sends Hand Grenades As Yule Gifts

OMAHA, Neb. (UPI) — Investigators today tried to track down four missing hand grenades that may have been wrapped as Christmas gifts and mailed by an ex-convict to persons on his select "hate list."
Police said Richard Carl Nielson, 39, compiled a list of 22 persons living in Omaha, Arizona, Oregon and California who he felt were "responsible for the problems of my family."
Nielson told investigators that he purchased 30 grenades. By today 26 were accounted for and police feared the other four may already be in the Christmas mails.
Some of the recovered grenades were examined by an Air Force bomb squad, which said the weapons contained enough black powder to kill a person.
The search for the grenades began Friday when Nielson told authorities about the list and said he had already prepared 13 bombs in small boxes for mailing. The grenades were set to go off when the receiver opened the box. Nielson denied mailing any of the grenades.
