CALL FOR BIDS The undersigned will receive sealed bids for the installation and construction of mercury vapor lights in the City of Winston. Bids shall be in two groups:

Group I: Installation of mercury vapor luminaires of 40-watt, 2700-3000 Kelvin (comparable fixture) with lamp ballast complete with electric eye for automatic control, lighting electric power service, weather-proof disconnect, and 16-foot main arm. Bids shall include the furnishing of 600-watt mercury vapor lamp and necessary lary and equipment for making installation of a complete operating unit for said light poles.

Group II: The installation of twenty-three (23) mercury vapor lights to be located within the City of Winston, in accordance with the locations on file in the office of the undersigned and with the right to contact certain Pacific Power and Light poles or telephone company poles. It will be necessary to set five (5) 35-foot full-treated wood poles at certain locations. The poles to be installed on these 23 locations is a mercury vapor light with 175-watt mercury luminaire complete with ballast, electric eye and NEMA standards, type 2 and 4. Lamp shall be of equal and comparable quality. Fixture shall be controlled by a precision shutoff control and include a main arm not less than 30 inches in length.

On each light shall include the installation either on existing utility poles, for which permission has been granted, or to be set on poles owned by the City of Winston. The necessary labor and equipment for making complete installation and complete operating units, each light to include the hook-up of the same. Bidders should specify the cost for each installation at each location as the City will specify amount for this work and it may be necessary to delete one or two of the lights in order to come within budget limits.
