

NAACP Seeks New Order To Prevent Blackface Parade

PHILADELPHIA (UPI)—An order court order was sought today to prevent possible "widespread disorder and rioting" if blackface comics and minstrels march in the delayed Mummers parade here Saturday.

Mediators attempting to reach a solution to the touchy issue gained a last-minute reprieve Wednesday when the annual New Year's Day parade was postponed because of snow and freezing rain.

A hearing was scheduled before three Common Pleas Court judges today on a suit filed by former State Supreme Court Justice Thomas D. McBride seeking to ban blackface marchers and "those who would riot" if the traditional blackface makeup was used in the annual parade in Center City.

The suit was filed before the same court that rejected a request last Tuesday by the National Association for the Advancement of Colored People (NAACP) to ban blackface from the parade.

The court held at that time that city officials "have been quite diligent in seeing that the Mummers parade is conducted in a manner that is in no way offensive to our city."

The suit filed before Judge Theodore L. Reimel late Thursday sought injunctions against the use of blackface and demonstrations by civil rights groups.

Officials of the Congress of Racial Equality (CORE) and the Committee for Freedom Now, were subpoenaed to appear at today's hearing after meeting with police officials Thursday night.

Police officials cancelled all leaves and planned to have 1,800 patrolmen and plainclothesmen available along the route of the parade which starts in South Philadelphia and ends in Center City.

McBride said Thursday he was asking for the injunctions "because of the possibility of widespread disorder and rioting." He added that "I have been informed that pickets would come from as far away as New York City."

McBride filed the suit after he and the Rev. Henry H. Nichols, co-chairmen of the mayor's advisory committee, sought a solution to the dispute Thursday in a series of meetings with representatives of various community organizations.

Nichols, who is president of the Greater Philadelphia Council of Churches, said they were unsuccessful in attempts to "get other amicable solutions."

He said earlier Thursday that he and his colleagues "prayed for snow on New Year's and we got it."

He said the suit filed by McBride on behalf of the representatives of Catholic, Protestant and Jewish groups was different from the NAACP's action which sought to "enjoin the comics."

"We are seeking to enjoin the comics and those who would riot," he added.

The dispute in the annual parade, which traces its beginnings back to colonial times began when Magistrate Elias Meyers announced that blackface would be banned from the event.

He later rescinded his order after demonstrations in front of his home by some Mummers' groups but the city said marchers with blackface makeup would not be eligible for the \$64,000 in prize money.

Rusk Says JFK Was Unchanged On Cuba Policy

WASHINGTON (UPI)—Secretary of State Dean Rusk says that Cuban Premier Fidel Castro was "emotionally wrong" when he declared that the late President Kennedy had been contemplating a change in U.S. policy toward Cuba.

Rusk told a news conference Thursday that there could be no change in the United States' Cuba policy so long as the Soviet military presence remained and Castro continued to meddle in the affairs of his neighbors.

The secretary said he had found no evidence that Castro was willing to disavow the Russian penetration of the island nation or to promise to stop trying to subvert other Latin American governments.

Cuba was among the danger points listed by Rusk. Others included Cyprus, where the Greek and Turkish communities are again at militant odds; Yemen, where the United Arab Republic and Saudi Arabia support different sides in the overthrow of the royal government; Algeria and Morocco; India and Pakistan; Indonesia and Malaysia; and Somalia and its neighbors, Ethiopia and Kenya.

Rusk said the United States would use its "maximum influence" on the side of moderation in the Cyprus struggle. He said he had no knowledge that the U.S. 6th Fleet in the Mediterranean was engaged in any activity in connection with the dispute.

Brookings Man Pleads Guilty To Fraud Count

SAN DIEGO (UPI)—A Brookings, Ore., store clerk pleaded guilty Thursday in superior court to impersonating the son of U.S. Chief Justice Earl Warren.

Arthur M. Warren, 26, was ordered to return for sentencing Jan. 17. He is being held in county jail in lieu of \$2,000 bail.

Warren was arrested Dec. 16 in the El Cortez hotel where he was staying. He had identified himself to newsmen as Earl Warren Jr. and announced he was preparing for a visit here by the chief justice.

The hotel manager became suspicious because Warren had all his purchases charged to his room bill. The manager investigated, discovered the guest was an imposter and called police.

Thaw Warms Most Of U.S But New Cold Front Due

The great January thaw prevailed over most of the nation today, bringing record warmth to the Midwest, but forecasters warned it would be of short duration.

A dry cold front was pushing east along a line from Wisconsin to Texas. Behind it a snow storm was spreading from the Pacific Northwest into the Rockies and Central Plains. Snow was due late in the day in New England and rain mixed with snow was predicted for the Great Lakes area.

However, pending the arrival of the winterlike weather, the only areas reporting severe cold were in the extreme Northwest and Southeast areas of the nation.

It was a chilly 27 degrees at Cross City, Fla., while Chicago was reporting 39, New York 38, Boston 35 and Washington and Detroit 37.

The temperature dropped near the zero mark at Baker, Ore., while Davenport, Iowa, was recording a 14-degree temperature jump in three hours, to 47 degrees.

Buds peeped from the stems of flowers and shrubs in sections of Iowa, where the temperature hit 64 degrees at Council Bluffs Thursday. Des Moines, Iowa, had a high of 53, equalling a 1939 record for the date. Sioux City had its 24-year-old record.

Gusty winds stung Southern California with pellets of sand and threatened tidal flooding at Pierpoint Beach, near Ventura, an area hit by a similar disaster two years ago. Navy Seabees joined residents and county employees in placing sandbags across streets facing the ocean. Some homeowners dug trenches around their homes.

FBI Bares Red Plot Against Youths

WASHINGTON (UPI)—An American Communist party plot to exploit what the party described as a "drift toward the left" among the nation's youth was uncovered by the FBI in 1963.

FBI Director J. Edgar Hoover told of the Red youth scheme in his year-end report to Atty. Gen. Robert F. Kennedy, released Thursday. He also noted the FBI's investigation of the assassination of President Kennedy and of the murder of civil rights leader Medgar Evers in Mississippi.

Hoover said that last October delegates of the Communist Party U.S.A. met in Chicago "to lay the groundwork for a new national youth organization aimed at exploitation of what the party describes as a drift toward the left among young people."

secretary, Gus Hall, stipulated that the youth movement "should avoid the appearance, however, it should not tolerate anti-Soviet or anti-Communist party thinking."

Hoover said that following the assassination of President Kennedy at Dallas Nov. 22 "the full resources of the FBI were marshalled and an intensive investigation was launched concerning all phases of the assassination itself and the subsequent shooting of Lee Harvey Oswald. A detailed special report on these matters was prepared and furnished to the attorney general for transmittal to the President's commission investigating the assassination," he said.

He singled out for special mention the arrest of Byron De La Beckwith on civil rights charges arising from the ambush slaying of Evers, the Mississippi field secretary for the National Association for the Advancement of Colored People. Beckwith, who was turned over to Mississippi authorities, is awaiting trial for murder.
