Fannie Mae from Earnest Eugene Goin. Custody of their two minor children awarded to plaintiff, with defendant to pay \$40 monthly support. Property settlement agreement ratified.

Nancy C. from Allen S. Reed. Custody of their two minor children awarded to plaintiff.

Sharon Dale from Richard Eugene Joers. Plaintiff awarded custody of minor child.

Judith Kaye from Michael Monroe Darby. Custody of minor child awarded to plaintiff, with defendant to pay \$50 monthly support. Plaintiff awarded household furnishings, with defendant to pay indebtedness. Defendant to have 1953 automobile and television set.

Thelma from Ehrman Smirl. Separation awarded to plaintiff for unlimited time. Custody of minor child awarded to plaintiff. Plaintiff granted life estate in property in Winston. Defendant, in lieu of support money for child, required to pay installment payments on the property. Defendant to pay plaintiff \$200 monthly for her support and maintenance during the period of separation. Defendant awarded 1955 automobile, and plaintiff to have furnishings of home.

Order

Clifford D. vs. Gertha M. Collins. Court order restrains defendant from in any manner threatening, molesting, vexing, harassing or otherwise bothering plaintiff or disturbing the plaintiff's peace and tranquility, either at plaintiff's place of business, publically or privately, by telephone calls or otherwise.

Estella vs. Floyd Eugene Powell. Married at McMinnville Aug. 19, 1942. Plaintiff claims defendant in 1960 left their home and has not returned. Plaintiff asks custody of their four minor children and \$40 monthly support, plus attorney fees.

Gust J. vs. Gladys Marie Haft. Married at Kansas City, Kan., Dec. 24, 1946. Cruelty charged. Plaintiff asks custody of their three minor children.

Randall J. vs. Lynda L. Parmelee. Married Jan. 19, 1963 in Tacoma. Cruelty charged. Plaintiff asks award of 1957 automobile and that household furnishings be awarded to defendant.

Ada vs. Marvin Vincent Rathal. Married in Sutherlin May of 1962. Cruelty charged. Plaintiff asks for award of property on Newton Creek Road, subject to incumbrance; award of household furnishings, with defendant to assume obligations, and also savings account in a local bank. She asks that her former name of Ada Munoz be restored, and that defendant pay attorney fees and court costs. She also asks a restraining order against the defendant and a show cause order as to attorney fees and court costs.

JoAnn Beverly vs. Stanley Carl Schilling. Married at Couer d'Alene, Idaho, July 3, 1955. Cruelty charged. Plaintiff asks custody of their three minor children and \$40 monthly support for each. She asks award of real property at 210 Ivan St., Roseburg, miscellaneous household furnishings and 1955 pickup. She would award 1961 automobile to defendant. Plaintiff asks court order that defendant be required to remove himself from their home, that he be restrained from molesting or interfering with her; that she be awarded temporary custody and show cause order asked as to attorney fees, suit costs and child custody.

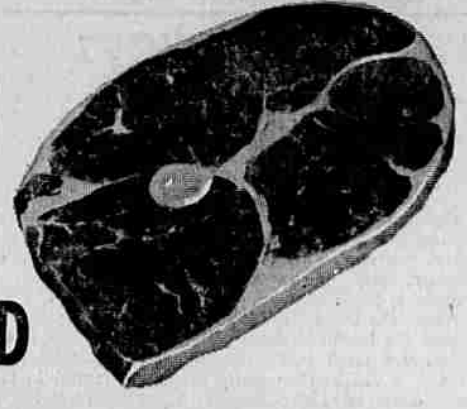

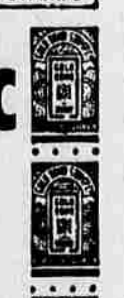

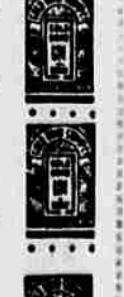
