And by its attorney complains of the

And declares:

I. For that whereas the plaintiff law school has acquired by long and continuous user certain prescriptive and preemptive rights in the stream of feminine pulchritude which hath since time whence the memory of man runneth not to the contrary, and long before and continually from thence hitherto, flowed there near adjoining to the plaintiff's premises;

II. III. IV.
