### Official ASUO Election Decision Revealed

# Illegality of Thursday Elections

rested primarily in the use of educational activities cards, as means of identification, a decision of the ASUO judiciary committee, released Friday afternoon, declared.

Article II, Section 1 of the ASUO constitution provides that "All registered undergraduate students of the University of Oregon shall be members, if they pay such fees as are determined by the by-laws."

Furthermore, the decision declared, Article II, Section II provides that "Regular undergraduate students registered in the University of Oregon may exercise the right of franchise in all ASUO elections."

Students who carry less than six hours of college work do not receive educational activities cards. Because of this the judiciary committee ruled that election officials had "in fact disenfranchised every part-time student on the campus of his constitutional right to cast a ballot in the election."

The decision explained that the registrar's office had supplied the judiciary committee with "information which leads to the conclusion that there are more than one hundred of these students on the campus."

#### Graduate Students

The committee found the election further unconstitutional on that fact that graduate students, who do receive activities cards, are not constitutionally able to

Election officials, the decision ruled, "Did in fact enfranchise those graduate students who appeared at the polls and sought to cast a ballot, using their student activities card as the identification basis for their right to cast a ballot."

"The judiciary committee has ample proof that a large number of graduate students did in fact vote at the elections. They clearly had no right to vote, and to have such votes cast by them rendered the election illegal."

The conclusion of the decision cautioned, "The members of the

ASUO should take note of the fact that it is not the task of the judiciary committee to work out the mechanics for holding legal elections under the ASUO constitution. The judicial powers and obligations of the judiciary committee empower it only, and properly so, to pass judgment on the legality of procedures devised by those officers of the ASUO, who under the constitution have placed on their shoulders the responsibility for supervising elections.

"However, it is the opinion of the judiciary committee that the task of preparing a set of election rules, which would guarantee legal elections, is not a particularly difficult one, although it will doubtless require the expenditure of some time and perhaps some money."

"It is the judgment of the judiciary committee that the blame for the invalid procedure which was adopted for the election of May 8, cannot and should not be placed upon the shoulders of any one man."

"For that matter the entire student body is somewhat to blame because of its failure through its amending powers to set up a constitution and by-laws so clear in their instructions to the officers, that such unfortunate mistakes as prevailed in this election could not be made."

#### Less Damage

Less damage was done the University, the decision said, by the committee's ruling the election invalid when they did, than had "The matter been allowed to drag out into a series of election protests and contests following an official closing of the polls and counting of the ballots."

In closing the decision, the committee advised that the proper steps for officials to take is to "Set a date for a new election, and in the meantime, devise a set of rules which will guarantee proper identification of all those who are entitled to vote, and which will prevent the voting of those not entitled to cast a ballot under the existing ASUO constitution and by-laws."
