He also told the Emerald that he will talk to University President Harry Newburn concerning the suspension. Individuals and houses are behind a move for reinstatement. Peterson said, and he indicated that he hopes for probation for the two basketball players next fall.

Peterson announced Wednesday that he is heading a movement for a new hearing. He stated that he has consulted outside legal advice.

Any appeal for a new hearing of the case would have to be placed before the general faculty Donald DuShane, director of student affairs, suggested, since the Student Discipline Committee is an agency of the faculty. DuShane said that no regular appeal procedure is in existence to his knowledge.

Loscutoff has admitted that the suspension was based on a morals charge. The discipline code adopted by the Student Discipline Committee in 1946 and approved by the President of the University, lists the penalty for offenses of a moral nature as explusion, or permanent removal from school.
