## Reagan pursues militarist course, according to Tass

MOSCOW (AP) — The official news agency Tass today accused President Reagan of using anti-Soviet slander and "confrontationist rhetoric" to justify his request for a \$320 billion defense budget.

"At a time when the Communist Party of the Soviet

Union from the rostrum of its 27th Party Congress is appealing to reason and conscience of all mankind in the name of ending the arms race... Washington has openly proclaimed the intention of going ahead with its militarist course," Tass said.

On Wednesday night, Reagan said it would be "reckless. dangerous and wrong" for Congress to cut his requested defense budget, saying that "could fatally compromise our negotiation position" in arms reduction talks with the Soviet

Another Tass commentary said Washington does not think it needs better international relations, and that Reagan is trying to take an unacceptable approach to the issue of missiles

## Aquino expected to free hundreds of prisoners

MANILA, Philippines (AP) - President Corazon Aquino's Cabinet officers took over their posts Thursday and Aquino ordered all departments to preserve their records because of reports that some had been destroyed by supporters of the deposed Ferdinand Marcos.

The new government said hundreds of political prisoners held by the fallen Marcos regime probably would be freed next week


Thirty-nine prisoners were ordered set free Thursday. but by nightfall only one actually had gone home, said Armando Malay, head of a prisoner families group called Kapatid (Brother).

All 39 prisoners were taken from jails to special centers, however, and had emotional reunions with relatives whilebureaucrats dealt with the documents.

Officials said more than 500 people were in fail on assorted political charges when Ferdinand E. Marcos ended 20 years of rule in the Philippines and fled the country

Wednesday in a U.S. Air Force plane. He now is in Hawaii. Philip Habib, the special U.S. envoy, spent 11/2 hours with Aquino on Thursday. A statement from her office said. Habib extended "the warmest greetings of President Ronald" Reagan and the American people.
