Hilton Hotel, 66 E. Sixth Ave., for a few days until they left for California.

The doctor, who the Eugene Police Department says is an anesthesiologist from New York, is the woman's husband and was in charge of tape recording and photographing the sexual encounters between the woman and the participants.

Three University men who had been propositioned by the woman took the letters and contacted the EPD with the information, police reports stated.

Two plainclothes officers went to the hotel room Sept. 16 to investigate the set up. One of the officers posed as a University student and entered the room to find the woman and the doctor with a camera around his neck.

After the police identified themselves, they issued a cita-

tion of promoting prostitution to Rodney Thorp Wood, 60, and a citation of prostitution to Nancy Steffen Wood, 44. The couple listed on police reports South Hampton, N.Y. as their home.

During questioning, one of the officers asked the doctor to explain the letters.

"Well, I'm a doctor and she (Nancy) is my wife," he said. "She is assisting me in my experiment. By tape recording and photographing my wife while she is engaged in intercourse with young, well-fit males, I can determine the intensity of her orgasms."

The officer told Mr. Wood that the incident was prostitution, but Wood said he had not realized that, say police reports.

"It's for medical purposes," he told the officers.

In addition to a tape measure

and condoms, police confiscated from the hotel room tape recordings, film and papers listing performance evaluations of two men from British Columbia and of a University student.

Police cited the University student Sept. 20 for prostitution, which Oregon law partially defines as engaging in sexual intercourse for the purpose of receiving or giving money. Promoting prostitution is defined partially as inducing someone to engage in prostitution.

The *Emerald* is withholding the student's name pending the filing of official charges by the district attorney's office. The student said he had met Nancy on the street and spoke with her. She called him at his residence later that evening.

"When she called me I was drunk. She said she wanted to meet me — so I did," he said. "I didn't think it was prostitution."

The student said Nancy picked him up on campus and drove him to her hotel room. Before the encounter, the doctor asked him to sign papers stating that he did not have any communicable diseases.


"They looked official," the student said. "He said he was writing a scientific document."

Rodney and Nancy Wood are scheduled to appear in court at 9:30 a.m. Monday. The student is to appear at 9:30 a.m. Thursday.

Assistant District Attorney Sean Hoar would not say whether he thought the charges would be dropped.

"It's inappropriate for me to comment at this time," he said.

any legal rights," Krummel said.

Lawry said he was unaware that any tenants were even living in the building.

Tenants of the building are worried that the building has been "slated for destruction," and will become part of the hospital's expansion program. But Lawry said that the hospital has "no predetermined plans for the building for use by the hospital."

Although there are no city regulations protecting the building, it has a "definite historic significance to the community," said Teresa Bishow, senior planner for the Eugene Planning and Development Department.

The building was built in 1925, to replace an older wooden grocery and apartment building that was built in 1910 and later moved to a different location.
