"Modified anonymous" testing means a student's human immunodeficiency virus test is identified only by a number on the test chart, and is not included in regular health charts. Confidential testing means components of a student's health record, such as psychiatric history or substance abuse, cannot be released along with the main record unless the student signs a release form.

Student charged in riot to begin trial Tuesday

A University student arrested last year for rioting at an off-campus party is scheduled to go to court Tuesday.

The student, Dainard Jon Paulson, pleaded not guilty last year at his arraignment, where he was charged with rioting, a class C felony.

Four people were arrested last year for rioting at 14th Avenue and Ferry Street when a May 5 party in the area moved from a house into the street.

Paulson said his attorney advised him not to speak about the case.

His attorney, David Hill, said rioting is a complex charge. To be guilty of rioting, a person must have been working in

conjunction with five other people, and they all must have engaged in "the same tumultuous, violent behavior," he said.

"They're saying (Paulson's) acts amounted to a specific crime," Hill said.

However, Hill said Paulson's involvement in the incident did not rise to the level of a felony.

"We're going to make them prove their case, if they can do it," Hill said.

The other three people arrested May 5 for rioting are Shelly Marie Hannah, Justin Theodore Kulongoski and Mark Eric Miller.

Paulson and Hannah are Uni-
