# Amendment to target recruiters

The Student Senate decided Thursday to form a committee that will meet early next week to amend a proposed resolution by deleting specific references to the Central Intelligence

Agency.

The existing resolution asks the administration to force the CIA to sign an affirmative action statement saying they do not discriminate on the basis of sexual orientation.

The committee will meet Monday at 6 p.m. in the ASUO office. At that meeting members will decide if they should remove references to the CIA and focus the resolution on having all potential campus recruiters sign an affirmative action statement.

The amended form of the resolution will be voted on at a Senate meeting next Thursday

Chairperson Tiffany Weed urged all students wishing to voice their opinion on the matter to call the student senate office

Guest speaker Tim Hughes said he supported the idea of including all recruiters on the resolution. He also urged the senate to send a strong message to the administration.

"What we're asking you to do is very simple," Hughes said.

"We need you to send the strongest possible statement to President Brand that says. 'Please make Larry Smith, the director of career planning and placement, do his duty.

"Please make him uphold the state laws and the (Oregon Administrative Rules). Please make sure he asks every single employer to sign a legal document that says they agree not to discriminate against any University student based on any

extraneous factor."
Hughes said he guaranteed that the CIA would not sign such a statement.

A second guest speaker. Shannon Oliver, said the gay and lesbian community feels that a statement from the student senate would be very powerful and meaningful.

"We need help. We need widespread representation and some feedback about how the general campus does feel about this." Oliver said.

"As it stands now, gay men and lesbian women have no protection. Their rights are not protected under federal or state laws.

"But they are protected here at the University under the OAR rulings So as a student body we have to fight for that protection, for anyone who comes here."

### Campus dog patrols resume

Campus dog owners are warned that Lane County Animal Regulation will resume its patrols of the University area Monday, said Animal Welfare Officer Judy Finch.

University patrolling was not a stipulation in the wording of a contract the University had with Lane County and the City of Eugene.

"It was never specified in the contract that Lane County Animal Regulation was supposed to patrol the University." Finch

This led to a suspension of patrols over the summer and into the school year as the contract was being reworded, she said.

tations for unleashed dogs, unlicensed dogs and dogs that are left tied outside (while someone is in class, for example), even if the tied dog is licensed.

"The City of Eugene and the University want us to be very strict with these policies." Finch said.

Reasons for the ordinances are for the safety of the animals as well as people, Finch said


"You never know who is going to come along," she said of the tied dog ordinance. "Someone could untie the animal, or it could get soaked in the rain or could get too hot in the sum-

The reasons for licensing your dog are self-evident, she said.

If a dog is licensed but running loose, "we can get that dog home," she said.

Citation amounts for dogs running at large or for not having a license are \$35 in most cases, she said.

Licensing and rabies vaccinations are available at the Lane County Animal Regulation Offices at 3970 W. First Ave. Licenses are \$5 per year for neutered or spayed dogs and \$15 for dogs that have not been sterilized.
