Advertising, internal problems hinder Incidental Fee Committee

Internal communication problems, hiring of new members, and misunderstandings with the *Oregon Daily Emerald* have created a backlog of the Incidental Fee Committee's budget hearings.

The IFC hired two new members, Joel Revill and Chad Bennion, at the end of winter term and the middle of budget hearings, said Freddy Vilches, vice-chair of the IFC.

It was difficult because the IFC had to stop and train the new members and schedule new hearing times, said Armando Morales, IFC member. This made it hard to continue with the hearings, he said.

Miscommunication between IFC members also made it difficult to update Revill and

the problems.

Christopher Blair, *Emerald* news editor, said there have been problems with advertising

meetings a week with more than six groups scheduled to appear each time.

The ten groups who have requested budgets under \$5,000 will be heard from first and then the remaining 17 organizations with budgets over \$5,000 will go, Vilches said.

"With the current plan we should be done with all the groups in two weeks," he said.

That will still leave the IFC with a few weeks to prepare a document listing all the budget appropriations that must be given to University President Myles Brand on May 10 for approval, Vilches said.

Vilches said although student groups will receive ample notification of their scheduled budget hearing, they will not be subjecting them to the new rule to help speed the process.

Bennion, causing yet another reason for the setback. Members don't see each other often, Morales said, adding that he usually talks only to Vilches and Bennion regularly.

Finals and registration also made it hard to find the time for members to meet, Morales said.

Another contributing factor to the backlog were misunderstandings between the IFC and the *Emerald*.

The IFC has had to cancel more than one budget hearing because the meeting was not advertised in the Et als section of the *Emerald*, Morales said.

"I've been frustrated because I've been with the IFC for five years and this (the cancellation of many meetings) has never happened," Morales said. However, he says he does not blame the *Emerald* directly for

the IFC meetings because they are the only group that needs to have their meetings announced two days in advance, a provision of the Oregon open meetings law.

Other group meetings are advertised the day of the event.

ing Et als forms have caused the mix-up, Blair said, adding that this will no longer be a problem.

In an attempt to alleviate the problem the IFC will be adding more hearings to their weekly schedule. There will be 2-3

The rule instituted last term stated that if a student group did not show up for their hearing, they had to submit a written statement explaining their absence to the IFC within five days after the scheduled meeting.
