Dennis Gilbert, University physics professor and ESSN cochair, said. 'The company made a mistake. The company has been hurt severely by the strike. They didn't realize that the community here wouldn't stand for that kind of exploitation. Scabbing is the only way Morgan has gotten around the will of the community.

ESSN has organized monthly support pickets at the Nicolai plant that have been strongly supported by such University student groups as University Democrats, The Student Insurgent, and the Survival Center.

State legislators have recognized the bitter schism created in the community by the labor dispute. In January, 1989, a Lane County delegation sent a letter to Arthur Knight, president of Morgan Products, asking Morgan to submit to binding arbitration to end the labor

He was elected to the U.S. Senate in 1962 and served three terms.


