Incidental Fee candidate Freddy Vilches said he can offer the IFC the dedication, organization and experience that it needs to allocate student fees fairly.

Vilches, who is currently the acting IFC chairman, is running for his second term as an two-year committee member.



Vilches, a senior majoring in psychology and Spanish literature, said he decided to run again because he feels he has the experience and commitment required for the job

"I've been on both sides of the table." Vilches said. "submitting budgets and being on the IFC."

Vilches was in charge of the budget for MEChA when he was co-director from 1987-88.

He also served on the Bookstore Board of Directors from 1987-88.

"I can bring commitment and I think I've shown it through my two years involved with the IFC." he said.

"I think I've already made a difference since I became acting chairperson," he said.

The IFC will be done with budget hearings in about a week and should not have any problem meeting the May deadline. Vilches said

The most important thing an IFC member should be doing is advocating for student rights, making sure that their money is spent in the best possible way. Vilches said.

"It's important that members of the IFC be very aware of the fact that if we don't act responsibly our right to control student fees will be taken away." he said.

"I'm here to make sure we continue having control over our money and fees," he said.

"If I get elected I want to start planning from the very beginning of next year." Vilches said, "so all groups know what to expect, when budgets are due, and when hearings are."

"This will avoid any misunderstandings and speed up the process." he said.

Vilches said he also wants to make sure that hearings are not inconvenient for groups and

IFC members.

"I don't want to have hearings lasting all night with people waiting for their turn." he said, adding that he plans to distribute hearings evenly to avoid delays with budget appropriations.

"There will be plenty of time to get on with the budget if it's done in a systematically planned way," Vilches said.

The IFC needs people who will keep their office hours, attend meetings, and have the capability of preparing fair budgets, he said.

Vilches said he employs voters to elect people that have the qualifications and the willingness to commit themselves to their job.

Umbrella, smoking restrictions to be subject of public hearing

Public hearings on two rules that would ban open umbrellas in Autzen Stadium and extend smoking restrictions in many University facilities will be held today at 3 p.m. in the EMU Walnut Room.

Under one of the proposed administrative amendments, the smoking ban would be extended to include Autzen Stadium, and Hayward and Howe fields.

University athletic department officials proposed the bans on umbrellas and smoking out of concern for the health and safety of fans.

Sports fans had complained that the use of umbrellas during football games blocked their view of action on the field. Athletic department officials, citing similar bans in other college stadiums, are concerned that the pointed umbrella ends could injure boisterous fans.

The proposed smoking ban is designed to reduce the risk of fire. Moreover, a spring 1989 survey on smoking in University buildings found that one-half of University employees favor a building-wide smoking ban.

The public may comment on rule changes orally or in writing at the hearing. Written comments may also be filed by 2 p.m. today in

Room 202 Johnson Hall.

The proposed amendment to ban umbrellas at Autzen would prohibit open umbrellas in all seating areas, seating area aisles and standing-room-only locations during University home games.

The amendment authorizes fines for those people who violate the smoking rules.

Smoking would be banned campus-wide in classrooms and in workrooms and buildings ventilated by recirculating air systems.

Moreover, smoking would be prohibited in any building designated by building users as a non-smoking facility and in Universityowned vehicles operated by more than one person.

Copies of the proposed amendments are available for public viewing in the offices of the president, vice presidents, assistant to the president for legal affairs, athletic director and in the reserve section of the Knight Library.

University administrators will consider the testimony submitted prior to and during the hearing for two weeks before filing any rule changes with the Secretary of State's office.
