

## Police Beat

The following is a list of campus area crimes taken from Office of Public Safety and Eugene Police Department reports between April 26 and May 6:

- Attempted burglary and criminal mischief at Delta Gamma sorority, at 1584 Alder St., was reported to EPD on May 6. Five college-age men went to the front and back doors of the residence, kicking them and screaming.

One man attempted to enter through a screen door while another climbed a wood rack against the wall. There they attempted to remove a window screen, causing \$10 damage, and screamed obscenities.

The complainant turned on

the porch light and looked out the window. The suspects then fled the area.

The two suspects who attempted to remove the screen are described as white males in their early 20s, wearing white T-shirts.

- A University professor reported the theft of a \$25 hatchet from his Condon Hall office to EPD on May 4. There were no signs of forced entry.

- A purse was reported stolen at 13th Avenue and Kincaid Street to EPD on May 4. The owner left the purse, containing earrings, medication and a checkbook, on a wall while getting some flowers from a nearby flower stand. The total loss

was \$181.

- EPD arrested two University students for stealing a Eugene parking meter on May 3. EPD officers were dispatched to 12th Avenue and Kincaid Street in response to a report of two males attempting to steal the meter.

The officers arrived and observed a trail made by concrete dragged along pavement. The officers followed the trail to the Sigma Nu fraternity, at 763 E. 11th St.

After further investigation the students were arrested and taken to jail.

- The theft of \$2 from a sanitary napkins dispenser in the Bean Complex basement was

reported to EPD on May 3.

- The theft of a backpack outside the University Inn cafeteria was reported to EPD on May 3. The owner left the backpack outside the cafeteria, containing textbooks, a wallet and \$5, while getting some juice and returned to find it missing.

- A \$54 student parking permit was reported stolen from 11th Avenue and Kincaid Street to EPD on May 3.

- A \$350 Mel-Temp was reported stolen from the Klamath Hall basement to EPD on May 2. The scientific equipment is used to determine what an organic compound is by its melting point.

- A backpack was reported sto-

len from EMU second floor to EPD on April 28. The owner left the backpack, containing keys, blank checks and credit cards, on a window seat and returned to find it missing. The total loss was \$82.

- A housekeeper reported damage of the Carson Hall elevator to OPS on April 27. An unknown suspect entered the elevator and caused \$250 damage to the circuit system and control panel.

- The theft of a \$277 AM/FM cassette radio from Bean Complex parking lot was reported to OPS on April 26. An unidentified suspect broke the passenger-door window to steal the radio, causing \$120 damage.

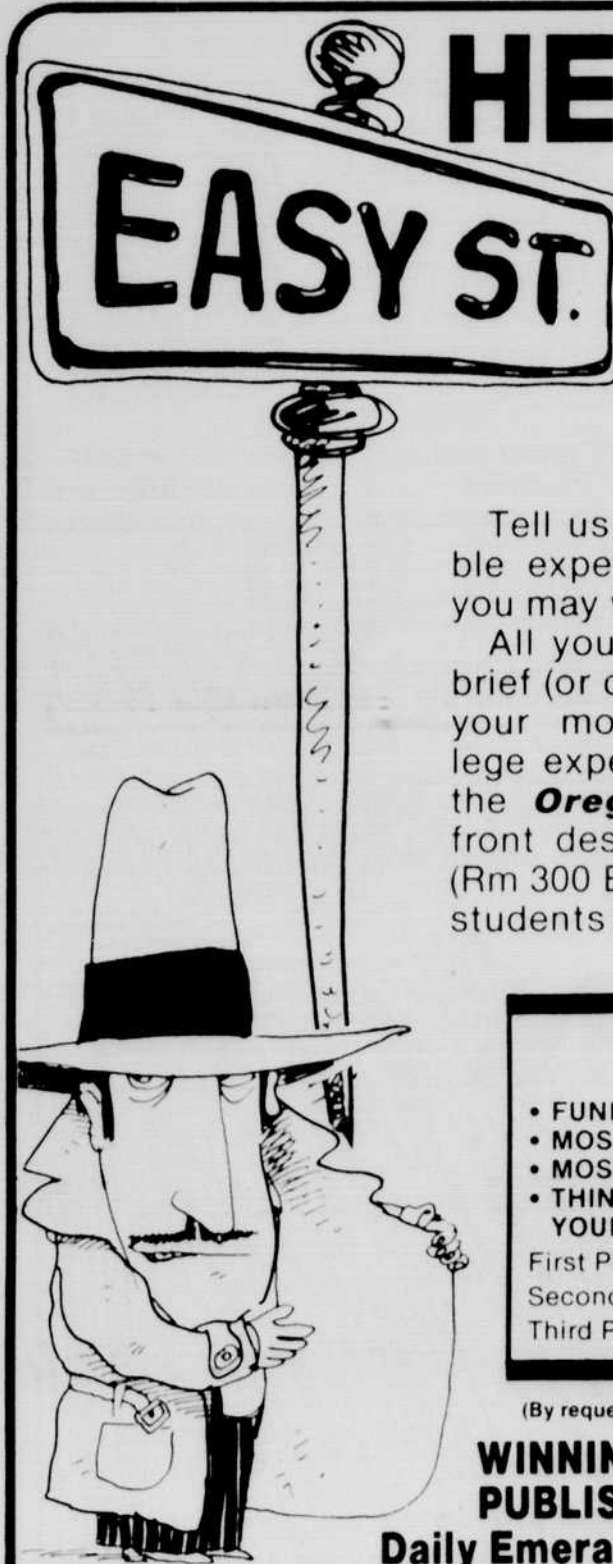
