The 1990 National Collegiate Division I women's softball championships begin this week. with Oregon playing Kent State and Ohio State in the Mideast Regional Friday

The tournament finals will be played at the ASA Hall of Fame Stadium, Oklahoma City, Okla. Four of the regionals will be twoteam contests; the remaining 12 teams will play round robin three-team regionals.

Wessell eams athlete of week honors

After turning in the thirdfastest time in Pacific-10 Conference history in the 5,000 meters, Oregon's Stephanie Wessell has been named the Pac-10 women's track athlete of the week

Wessell finished third in the 5,000 at Saturday's Oregon Twilight Meet, turning in a time of 16:08.87 to break the NCAA qualifying standard of 16:16:00. Wessell is the Oregon women's first Pac-10 track athlete of the week this season.

Wessell's time broke her

old personal record by more than 17 seconds. Only Oregon's Annette Hand and Penny Graves have faster times in Pac-10 history and Wessell's performance is also the sixth-best in school history.

California's Laura Baker wins the women's field award for scoring a PR 5,365 points in the heptathlon at the Occidental Invitational meet in Los Angeles. Baker's score is the third-best mark in the Pac-10 this year and qualifies Baker for the NCAA

On the men's side. Washington's Todd Wilson wins the field event award while the track award went to USC sprinter Quincy Watts.

Wilson threw the discus 190-6 for a PR at the Seattle Pacific Invitational at Seattle last Saturday. The mark also breaks the NCAA qualifying standard of 190-3.

Watts ran the 200 meters in a time of 20.66 at the Occidental Invitational last Saturday. The time ranks third in the conference this season and qualifies Watts for the NCAA meet.

Brandon cited for speeding near Portland

rell Brandon was cited Monday near Lake Oswego for speeding, driving without a license and giving a false name to police officers.

Brandon, a sophomore point guard for the Ducks, was stopped by state police along Interstate 5 near Lake Oswego at 2:45 a.m. for driving 82 mph in a 55 mph speed zone while traveling southbound, said Sgt. Aaron Olson of the state police district headquarter office in Portland Drugs and alcohol

rest, state police said.

After being pulled over by police, Brandon gave a false name to police. Olson said. because he didn't want publicity from the arrest. He later gave his correct name which another officer confirmed. The officer "... is a fan of the Oregon basketball program," Olson said.


Brandon was cited for exceeding the maximum speed. which carries a \$172 bail; giving a false name to a police officer, which has a bail driver's license, a \$172 bail.

Giving a false name to a police officer is also a Class A misdemeanor in Oregon and carries a possible jail sentence. Brandon will appear in Washington County District Court on May 29 on all three charges. Brandon had reportedly been in Portland visiting his mother during Mother's Day. Brandon and three other University students were then traveling back to Eugene when the arrest occurred, state police

A cousin of Brandon's was reportedly driving the car but later gave Brandon the wheel because he felt sleepy.

Brandon was in Eugene Monday afternoon and said he had no comment on the arrest although he did say that he doesn't think the incident is a reflection of him personally.

The Oregon Sports Information Department said Monday that no team disciplinary action would be taken against Brandon.


