The three-day trial included testimony from the woman, her roommate, Horton and a host of defense witnesses who spoke on his behalf.

The woman testified that Horton and his then 16-year-old cousin took her to their former residence in north Eugene

and had sexual intercourse with her against her will.

She said that she repeatedly asked the two men to take her home and that they ignored her struggles and pleas to be left alone.

The woman admitted being intoxicated and accepting a ride from Horton prior to the incident, but maintained

throughout the trial that the intercourse occurred entirely without her consent.

"I felt like I was being dominated by two people. I felt they had done something I didn't want done to me," she said.

Horton contended the woman initiated the conversation and subsequent sexual activity between them and in no way

resisted or struggled.

"She came on to me," Horton testified. "She initiated it."

Other defense witnesses, including Oregon defensive back Daryl Singleton, former Oregon defensive back Daryl Reed and Horton's cousin, corroborated Horton's claim that the woman was dancing suggestively and acting in an aggressive manner

during the fraternity party.

Horton's cousin also testified that during the incident, the woman made no attempts at resistance, never said she wanted to go home and "...made statements that led me to believe she wanted to continue."

The cousin, a minor, is facing charges for the incident in juvenile court.

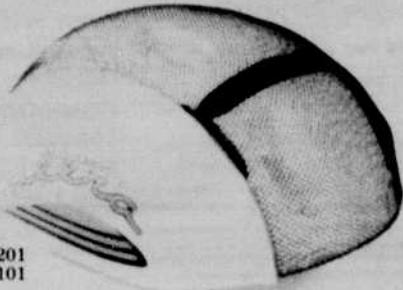

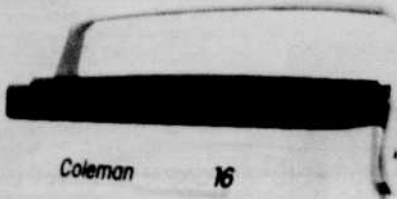

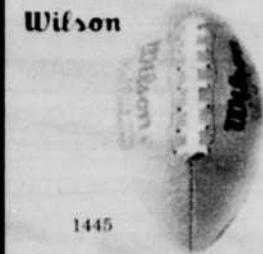
