DeFexio knows the issues, knows Oregonians and will continue to lead the progressive battle in the 1990s.




Return Edmunson, Hosticka, Dix to House

Mark Hatfield believes that the unborn child, regardless of the circumstances of conception (including rape or incest), possesses an inalienable right to life. Hatfield is running for senator against Harry Lonsdale, who is pro-choice.

In the gubernatorial race both candidates are pro-choice, but Barbara Roberts received the endorsement of the pro-choice groups because she did not waffle about coming out strongly against measures 8 and 10.

Finally, David Dix is the prochoice candidate in the District 41 Oregon House race.

Last September Jeanette Turk, executive director for the statewide No on 8 and 10 campaign, declined an invitation to debate with Measure 10 backers. Anti-choice advocates "misstate facts and misrepresent statistics," Turk declared. "It's not in the public interest to put forth that kind of confusion."

I'm inclined to believe that Turk's accusations are a projection of the pro-choice movement's own deceptive strategies.

The Becky Bell case is a perfect example. Sponsored by the Fund for the Feminist Majority. Becky Bell's parents have been speaking nationwide on behalf of their daughter who died of pneumonia, which the Bells believe was caused by an illegal abortion (allegedly obtained in Indiana, where parental notification is the law for minors).

The Oregon Daily Emerald printed a news article regarding Becky Bell's parents. Becky's alleged abortion was referred to as though it were proven fact. Yet Dr. John Pless,

head of forensic pathology at Indiana University Medical Center, who performed the autopsy, has said that he "cannot prove that she had an illegal abortion" or that she "had anything but a spontaneous abortion." (Cleveland Plain Dealer, Sept. 9)

Genna Southworth, who coordinates the National Abortion Rights Action League locally, insists that exactly how Becky Bell died is not important. On the contrary, if the public is being presented with speculation as though it is truth, I fell it's imperative that this be pointed out, especially in light of the fact that Becky Bell was scheduled for a legal abortion in Kentucky on the day following her death.
