

document (on the IFC computer) that he made during that time," Lee said.

He specifically stated that he was not in the office at all during the weekend of the ninth to the eleventh," Lee said.

That was proven to be false information as well, he said. Three witnesses, including IFC member Josonja Watson, said he was there on Sunday, Feb. 10.

'During an interview I asked (Colson) 'would you be surprised if I could prove to you that you were there during that weekend?' He would not answer the question, he just sat there," Lee said.

On Wednesday, Colson said he answered the question by saying he could not recall whether he had been in the office that weekend.

Colson was also asked during the interviews with Baily and Lee when he first knew the minutes were altered.

For the first two meetings that Kirk had with Mike, he stated it was (Feb.) 21st," Lee said, "We proved that to be wrong also. Days before the 21st, he heard other IFC members talking about

The section of the Jan. 31 minutes concerning

Ward complaint now read "complaint unfounded and dismissed." When Colson was questioned about the accuracy of those minutes, he again refused to respond, Lee said.

Colson said he did not refuse to respond to that question either.

"I didn't say I'm definitely not sure." he said. "I said I couldn't remember.

Barclay Grayson, an IFC member and Colson's running mate, said the release of the investigation documents will show that the ASUO was in-

"There are a lot of blanks, a lot of summaries," he said. "During the process of interviewing, I'd speak for five to ten minutes, they'd listen and then write one statement."

"That's the whole premise of my 'inconsisten-- they were writing not what I said but what they thought I said," Colson said. "By writing his opinion. (Bailey) can form as many inconsistencies as he wants.

Bailey has recommended that the IFC vote to remove Colson from office. No such vote has been taken, however, and IFC members suspended budget hearings indefinitely. Colson said he has volunteered to temporarily step down as chair-

Colson denies altering the minutes and says he will not resign from the IFC, as recommended by current ASUO President Kirk Bailey, who headed an investigation into the incident. As a result, all student group budget hearings have been suspended indefinitely.

Presidential candidate Scott Dunlap said he thought the note-tampering incident had been "blown way out of pro-

The real issue is that the IFC has shut down indefinitely," he said. "And they should be held accountable.

Later, Dunlap, responding to a question from an audience member, said if he were current ASUO president, he would do 'whatever it took' to resume IFC budget hearings, and added he believed "personal vendettas" in the matter should be put aside.

Colson was quick to respond. I will tell you right now, Mr. Dunlap, I don't have any personal vendettas," Colson said. "I have indicated that I'm willing to temporarily step down" so budget hearings can

On other issues, the six candidates were almost unanimous in their support for allowing gays and lesbians to live in University family housing, for making sure minority student programs receive adequate, stable funding and for trying to get more students to work together on campus issues.

All three tickets said they believe the University should set a statewide example by allowing gay and lesbian couples to live in University family housing, which is now reserved for married couples and single par-

Colson's running mate. Barclay Grayson, said it was also important to simultaneously lobby the state Legislature to validate domestic partnership agreements.

Also, the six candidates said they would ensure that programs geared toward women and minority students would receive adequate funding in the wake of Measure 5, despite a proposed enrollment cap that would leave the ASUO about \$400,000 short in student incidental fee income

Colson said he thought groups such as Black Student Union, MEChA and the ASUO Women's Center served important functions on campus, but he also believes students

should have an opportunity to vote on funding for such organ-

Another common concern expressed by candidates was including more students in ASUO activities and expanding participation in important campus issues, such as lobbying the Legislature for higher education funding.

Dunlap and Seeley proposed reviving the Programs Council as a forum in which the leaders of all ASUO groups could meet regularly to exchange information and ideas.

Running mates Jennifer Bills and JoSonja Watson said they would enlarge the Programs Council to include representatives of non-ASUO groups, including the greek system, offcampus living organizations. student parents and dormitory residents

The three tickets said they supported a boycott against Coca-Cola products led by the Black Student Union, Students Against Apartheid and several other student groups.

Wednesday's debate was sponsored by the Interfraternity Council and Panhellenic. Panelists from four campus publications took turns posing questions to be answered by each of the tickets, who were given three minutes to respond.


