Missing professor's vehicle, wallet found near river bank

Missing University professor Emmanuel Hatzantonis' car was found early Wednesday near Vida on Goodpasture Island Road, the Lane County Sheriff's Office reported. However, Hatzantonis has not yet been located.

A Eugene police detective said investigators are assuming Hatzantonis drowned at Marten Rapids.

Hatzantonis, 65, apparently left his Springfield home early Saturday and has not been heard from since, according to police reports.

At approximately 7:50 a.m. Wednes day, sheriff's deputies and Eugene police responded to a tip and found Hatzantonis' 1980 copper-colored Honda Prelude on Goodpasture Island Road off of Highway 126 at Marten Rapids

Eugene Police Department Detective Les Rainey said authorities found no indication of foul play. The vehicle was locked and some of Hatzantonis' personal effects - including a jacket, belly pack and an ice chest containing his wallet - were found on the river bank of the McKenzie River

The Lane County Sheriff's office and Explorer Post 178A searched the river and surrounding area on Wednesday afternoon but turned up nothing

Hatzantonis' wife, Gean, said he was an avid fisherman, but she didn't know if any of his fishing equipment was missing.

Jeff Ziller, district fish biologist for the Oregon Department of Fish and Wildlife, said Marten Rapids was the major rapid on the McKenzie River and described it as dangerous

Police are not certain what happened to Hatzantonis, but the best information would indicate he was a drowning victim, Rainey said.

He added that in most river-drowning

cases the victim's body remains submerged for several days before surfac-

"Within the next several days I expect some fisherman will probably find the body." he said.

From the articles surrounding the car and the fact that it was locked. Rainey speculated that Hatzantonis went 'down to the river for a specific rea-

"(Hatzantonis) felt a real bond with the McKenzie." Rainey said.

Hatzantonis, a Romance language professor, came under fire recently because of several complaints about the University's study-abroad program in Perugia, Italy, which Hatzantonis founded and directs.

Gean Hatzantonis said her husband was upset over the criticisms.

He was rather stressed," she said. "(Saturday) was such a nice day; I guess he needed to go up there and sort things
