Violations found at Trojan nuclear plant

RAINIER (AP) — The Nuclear Regulatory Commission notified Portland General Electric Co. of eight apparent regulatory violations at the Trojan Nuclear Regulatory Commission.

Among other violations, the NRC accused the utility of not taking samples of water, vegetation, soil and milk during an-

nual emergency drills the last two years; not checking the accuracy of two instruments at least once every two years; and not having a procedure to ensure that four instruments would not freeze if the plant lost outside electricity during freezing weather.

Also, the commission, found

two instances where procedures were not followed while preparing work instructions and said there were four errors in an emergency procedure used to shut down the plant if the control room had to be evacuated because of fire.

The violations are considered minor and don't involve fines.

Ripoffs irk Trail Blazers

PORTLAND (AP) — The Portland Trail Blazers, claiming a "Rip City" ripoff, threaten to sue a T-shirt company and restaurant for using "Rip City" in their names.

A local cable company pulls the plug on the telecast of a Blazer playoff game at an old folks' home.

The coach's daughter is arrested for selling T-shirts outside Memorial Coliseum.

The result has been a major public relations disaster for Oregon's only big-time sports franchise at a time when the Blazers are challenging for the NBA title and seeking public help in building a new arena.

The Trail Blazers notified Rip City T's and Rip City Diner that they intended to file a trademark infringement lawsuit if the businesses didn't stop using the name and give the team a share of past revenue.

The T-shirt shop's owner, 21-year-old student Roger Brooks, said he thoroughly researched the Rip City angle before he used the name.

Marshall Glickman, the Blazer's senior vice president, said the franchise has four contracts with companies to produce Rip City merchandise and that most of the royalties go to charity.

The Blazers have already been criticized for their strict cable television regulations. Most games not broadcast by NBC are blacked out except to pay-per-view customers.

In the middle of Tuesday night's game, a crew from Columbia Cable showed up at Cornell Estates Living Center in Hillsboro and pulled the plug.

A retirement center spokeswoman said the center violated the rules when it moved the cable box from a small room to a larger recreation area so more people could see the game.

Glickman said he was livid when he found out what Columbia Cable had done.

He said the Blazers plan to let all retirement and nursing homes have the games for free next season.
