## Decision on peyote was long overdue

Congratulations are in order for Gov. Barbara Roberts for signing a measure on Monday permitting Native American Indians to use freedom of religion as a defense for the sacramental use of peyote.

Sacramental use of peyote is permitted by the federal government and in some states. However, until now, Oregon law made no exception for religious use of the cactus drug.

The peyote controversy here dates to 1982, when two Native Americans were fired from their county jobs for using peyote in religious ceremonies.

Attorney General Dave Frohnmayer, who ironically was defeated by Roberts last year for the governor post, took the case to the U.S. Supreme Court. The court ruled in favor of the state, and religious peyote use in a country claiming religious freedom for all - remained illegal.

Using the hallucinogenic drug as part of a religion that existed in America long before the arrival of Europeans should fall under the religious freedom exemp-

Roberts was bright enough to understand that. Frohnmayer was not. It is yet another indication that Oregonians made the right choice last year when picking a new governor.

The bill's sponsor, Eugene Democrat Jim Edmunson, should also be commended for not taking the easy way out and ignoring the injustice done to Native Americans.


Board members act in matters of finance, policy and personnel. Members are required to attend monthly meetings and in some cases participate in committees requiring additional meetings

While the committee members did indeed revote on issues voted on originally at the June 1 meeting, it was not because we were in violation of the Oregon Public Meetings Law. There was some question that the June 1 meeting violated the Public Meetings Law by virtue of the fact that (need I remind you) the Et al submitted to the Emerald concerning the notice of our June 1 meeting was misprinted.

The Et al was submitted before the deadline in order to provide at least 24 hours notice of our upcoming Saturday meeting in the Friday, May 31, issue of the Emerald.

The Et al that was printed stated erroneously that our meeting was to be held on Monday because you interpreted June 1 to be a Monday and not a Saturday. Aghast at this error, we contacted the Emerald, the media and those people who were on the agenda to let them know the meeting was indeed on Saturday, June 1

Because of this error, there was some question as to whether the actions taken at the June 1 meeting were legal. In the Oregon Attorney General's Public lecords and Meetings Manual "Press Releases, pertaining to regularly scheduled meetings (page II-10), it is stated: "You are not held to a duty to be absolutely certain that the press release is published.

I would say we did all we could to ensure that the lawful procedure was followed. To answer our critics and the general public who probably didn't know the whole story, we voted again on every action at the June 7 meeting we originally voted on at the June 1 meeting.

Thanks for letting me clear this up.
