Research park goes ahead after six years

The University is moving forward with development of the 67-acre Riverfront Research Park on the Willamette River's south bank.

The project is a partnership between the University, the city of Eugene and the developer, Institutional Development Associates of Salt Lake City.

The 6-year-old project has been delayed in part because of land-use challenges and the withdrawal of the original developer, but is now proceeding on schedule, said Diane Wiley, University planner and project representative.

Recent developments include the August completion of Riverfront Parkway, an extension of Agate Street that will provide site access for construction crews and future tenants.

In addition, the Oregon Department of Environmental Quality has declared no further environmental work is needed at the site's Silva Orchard area. That parcel is the first of several that will be developed when tenants agree to locate at the facility.

The University joined the DEQ's Voluntary Cleanup Program this August and contract-

ed with Squier Associates Inc., of Lake Oswego, to do environmental assessments of the site. Their efforts have been monitored by DEQ and the U.S. Environmental Protection Agency.

Last year, Squier recommended sampling and monitoring of soils and groundwater at various locations throughout the site because of concerns about the presence of metals, such as cadmium, copper and zinc, and organic compounds, including methane.

The original developer, Carley Capital Group, was forced to file for protection from creditors under Chapter 11 bankruptcy laws in 1989.

IDA, the current developer, is primarily responsible for finding tenants, and construction at the site will not begin until tenants agree to locate there, Wiley said. The University will not discuss the status of tenant negotiations.

Critics charge the research park is the wrong project in the wrong place. Geography professor Al Urquhart, director of the University Environmental Studies Program, said the site was supposed to be reserved for a series of public playing

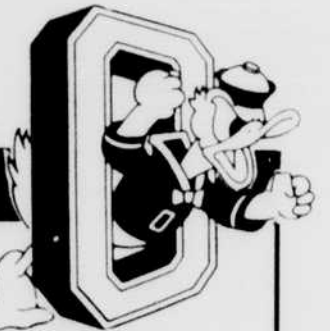

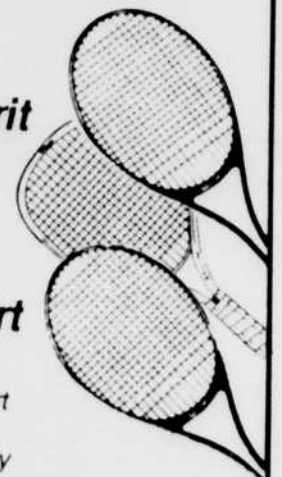
