of powers between policy and administration.

And Miller said that if the City Council is unhappy with the job the city manager is doing, the council can fire the manager. Miller said he believes the proposal shows that Sweet does not understand local politics.

'When somebody doesn't know what they're talking about, you feel sorry for them," Miller

ONE needs to collect about 7,600 signatures by Feb. 19 to get the initiative on the May ballot.

A spokeswoman in the city manager's office said City Manager Mike Gleason would not comment on the proposal because he is not an elected

Sweet said the city manager, as an official who is not elected directly, does not have to be accountable to the public for his decisions and actions in government.

Sweet, who said he has been a citizen activist for years, said he believes a more representative government will result from people voting for the combined city manager and mayor position.

Although the City Council is elected, and it in turn appoints the city manager, Sweet said this does not mean citizens get a city manager they believe is doing a good job.

"Do you think the council accurately represents you as a Eugene citizen? At most they can represent one-eighth of me," he said. "Here's the chance to have a (people's) victory."

Sweet said he expects wide support for the initiative from both Democrats and Republicans. And he said he has talked with politicians who are excited about the measure because they see it as an opportunity to create a very powerful, political city position that they are interested in run-

formance is being sponsored by the EMU Cultural Forum.

'He has a lot of information and analysis on what is going on," said Julie Lear, the contemporary issues coordinator for the EMU Cultural Forum.

'He has alternative perspectives on current events of government and news, and he is especially very critical. He challenges people to question the government and media," Lear said.

Because he was a radical rock star, Lear said Biafra was targeted by such people as Tipper Gore, the wife of Sen. Al Gore who campaigned for record warning labels. So Biafra is not just someone speaking about issues, he is someone who has had to legally defend

those issues, she said.

"He's really been through the ringer because of his views,' she said.

Biafra was involved in a highly publicized censorship court battle in which the nowdefunct Dead Kennedys were charged with "distribution of harmful material to a minor."

The internationally popular Dead Kennedys released the targeted album, FrankenChrist, in 1985. It contained a reproduction of a painting by the award-winning artist H.R. Giger in the record sleeve. The painting depicts 10 sets of human genitalia.

Biafra's defense called the poster a political statement that enhances the lyrics and shows how ugly it can be when people are screwing over each oth-

After 18 months in the court

system and \$75,000 in legal fees for the band, the jury acquitted Biafra.

But after the trial, the Dead Kennedy's broke up, Biafra's marriage ended and increased pressure from conservative groups resulted in the poster being removed from the album

Since the court case, Biafra has been expressing his political opinions in a more subdued manner than his traditional thrashing method of the Dead Kennedy's

Biafra has been touring college campuses across the nation addressing such issues as racism, record labeling, and his fear of "President Quayle.

"I have a feeling it will be more of a performance than a straight lecture," Lear said. It's not a set speech, but very free flowing.
