File it under Useless Information We Already

The University's Office of Student Affairs conducted a telephone poll in late October to determine the reasons 1,114 University undergraduates did not return to campus this fall. To the surprise of no one, more than a third had the same response: money.

What a shock. When members of the Oregon State System of Higher Education last year ballooned tuition rates at the University by 32 percent, they expected an enrollment drop. In actuality, it was part of the plan to relieve some of the higher education deficit compounded by Measure 5.

Unfortunately, they were all too successful. They were shooting for a loss of 2,000 students. They got almost 3,400. The University's enrollment fell 6.8 percent - nearly twice as much as administrators predict-


OSSHE's business sense is laughable. Trimming the fat off enrollment figures is one thing, but sticking it to students so they can't afford to return is quite another. Any gain the University's coffers got from the tuition hike has been nullified by the students flocking

For in-state residents, it's a no-win proposition. The tuition rate for the University is \$2,598 a year. Only the University of California at Berkeley has a higher rate among Pac-10 schools. Oregon residents who can't afford out-of-state tuition now can scarcely cough up what the University is asking.

In a state dying for college graduates, OSSHE has effectively slit its own throat. If it continues to cut programs and services while increasing tuition, nobody is going to want to attend the University. As unlikely as it seems, higher education in this state could very quickly close its doors.

The solution is obvious, but it's one Oregonians don't want to hear. Measure 5 left this state in poverty, and most residents are just now getting around to realizing it. Even slimming down existing programs won't be enough. More money is needed, and a sales tax is the best way to get it.

But Oregonian's won't go for it - or at least not yet. Perhaps the state will change its collective mind when higher education in Oregon crumbles into dust.
