## **ELIGIBILITY FOR AWARDS**

#### ERSTED AWARD FOR DISTINGUISHED TEACHING

The late Mr. A. J. Ersted established the Ersted Award for Distinguished Teaching so the University of Oregon could annually honor faculty members who have taught comparatively short periods and have demonstrated exceptional abilities to induce students to reason and not merely memorize.

The Ersted Awards can go only to faculty who are in their first seven years of university teaching. This teaching may occur at the undergraduate or graduate levels.

#### BURLINGTON NORTHERN FOUNDATION FACULTY ACHIEVEMENT AWARD

The generosity of the Burlington Northern Foundation has enabled the University of Oregon to honor a senior faculty member who has achieved an outstanding record as a teacher.

This award can go only to a faculty member who has held academic rank for at least seven years and who has demonstrated excellence in teaching at undergraduate or graduate levels.

• A 39-year-old man was caught trespassing on the University campus Feb. 10, according to police reports. The Office of Public Safety gave the man a letter of trespass on Oct. 6, 1991

On Feb. 10 a University student saw the man leave a stack of about 50 pieces of paper on the desk of the JSU's president. The student said the man stayed in the area for an undetermined amount of time and was acting strangely.

On the pieces of paper was written "Kill Jews: Whoops! We mean Zionists." The JSU's president told police the man had harassed JSU members on several occasions.

• A case of reckless burning occurred in Gilbert hall on Feb. 11, according to police. An officer was dispatched to Gilbert after a fire alarm was activated.

The officer found a lot of smoke coming from the second floor women's bathroom. Inside the bathroom was a plastic trash can partially melted at the bottom. The trash liner was also melted at the bottom. The officer found cigarette ashes on the ledge of an open bathroom window. The damage was \$20.

A 37-year-old Gilbert resident said last week she could smell cigarette smoke coming from the bathroom.
