er community and University resources to put on seminars and workshops. The workshops were to be every other week through May and were to be attended by no less than 80 percent of Phi Psi's live-in membership. The seminars were supposed to address topics such as sexual harassment, alcohol and drug abuse and sexism.

• Perform no less than 100 hours of community services on two weekends per month during winter term at one or more of the organizations, SASS, Women's Center, Lane Community College's Women's Center, Saferide and the District Attorney's Victim's Assistance Program.

In the resolution agreement, Rauch and the other woman agreed to develop a list of resources available to individuals who believe they have been victims of sexual harassment or rape and provide copies of this list by May 14 to the University Women's Center, the University and Lane Community College offices of affirmative action and student conduct, the *Oregon Daily Emerald*, the Incidental Fee Committee and the Panhellenic Council.

Both parties agreed to "avoid initiating direct or indirect contact" with each other for the duration of the agreement, from Nov. 18, 1992 to May 15, 1993.

Elaine Green, student conduct coordinator, and Everett Wells, affirmative action director, will meet next week to verify whether the fraternity and the women fulfilled their agreements by the deadline.

Rauch said the fraternity hasn't kept any of the good faith promises its members agreed to when they signed the contract. She's spoken to a lawyer about preparing a case against the fraternity.

Rauch said she has called the five organizations where Phi Psi members agreed to volunteer and organization members said they have not volunteered.

"It doesn't make sense they'd sign something they wouldn't honor," Rauch said. "I'm just so frustrated. I just want it to be done with. I'm transferring schools. I don't want to leave until this is settled and it's not."

The fraternity also didn't retain the services of Collier, Rauch said. Collier said she only conduct-

ed one workshop at the fraternity and was never paid.

"The only thing I want to say about this is we at SASS recognize Niki's feelings of frustration," Collier said. "We're saddened and disappointed that our training and expertise wasn't used more."

Green said the fraternity has complied with the provisions of an alcohol settlement signed with the Office of Student Conduct. Because the alcohol settlement and the resolution agreement shared some provisions, Green and Wells agreed the fraternity could fulfill similar provisions on both contracts at one time.

Phi Psi signed an informal settlement in November with Green after pleading guilty for violating the Living Group Alcohol Policy.

"The fraternity has complied 100 percent with the provisions mandated under the conduct process," Green said. "They've been very diligent."

The alcohol settlement included a provision requiring 100 hours of community service during winter term. However, that provision didn't specify the organizations where Phi Psi members had to volunteer.

Wells said the five organizations in the resolution agreement between Rauch and the fraternity were merely listed as examples of suitable organizations.

Schweitz said the fraternity has almost completed all of the resolution agreement's provisions. He said Green told him the fraternity didn't have to fulfill the provision requiring it to pay Collier \$1,000 for workshops at the fraternity.

Schweitz said Rauch violated the agreement by sending letters to Govro and himself. Schweitz said he will complain to Green and Wells about Rauch's letter. Rauch sent copies of the letter and resolution agreement to all of the greek houses.

Rauch said she sent Schweitz and Govro a letter to warn them she was taking her complaints to the *Emerald*. She said she interpreted the provision prohibiting any "indirect or direct contact" to mean phone calls.

Schweitz said the fraternity members just want to complete the resolution agreement by May 15 and "put this whole thing behind us."

"Basically, our house is slandered," he said. "I don't know where she comes up with these accusations. It's too bad Niki can't let this thing die."
