Miller, 23, hiding in the cemetery. When an EPD officer asked Miller if he was trying to break into the tunnels, he said, "Well, it's not like it sounds ... I made a large mistake."

Miller told police he decided to go into the tunnels after reading Zartman's *Emerald* article.

The EPD officer returned to the grate with Miller and found bolt cutters, a flashlight and a backpack. The grate was damaged, and Miller told the officer he and two friends were trying to cut through the grate.

When the officer asked why Miller ran from the police, he said, "I didn't run from the cops. It was a security guard. When I saw the real cops I gave up," according to police reports.

Despite persistent questioning, Miller would not give the names of the two other men he was with.

The arresting officer said he took Miller back to his residence on the 1400 block of East 19th Avenue after finding out Miller lived with five other men. The officer suspected some of Miller's roommates might have been involved in the attempted break-in.

The officer found the McKenzie brothers asleep on the floor of the house and woke them up for questioning. The OPS officer who originally confronted the group was also at the house and was able to identify Daniel McKenzie, 21, as one of the suspects.

After being identified, Daniel McKenzie told the officers, "We really didn't mean to destroy or steal anything. We just wanted to explore a little."

Daniel McKenzie also said he and Miller had been drinking and believed that the alcohol may have caused a lack of judgment, according to police reports. Andrew McKenzie admitted to being the third man involved after the three suspects were allowed to talk alone.

The officer cited the men for Attempted second-degree burglary and second-degree criminal mischief, both of which are Class A misdemeanors. A Class A misdemeanor carries a maximum fine of \$2,500 and one year in jail.

The three men were cited May 15, one day after George Hecht, University Physical Plant director, wrote a letter to the *Emerald* warning of the danger of unauthorized exploration of the utility tunnels.

Hecht also said students who enter the tunnels without authorization are in violation of the University's Student Conduct Code.

Because of federal privacy laws, any action taken by the University Student Conduct program will be confidential.

Zartman, a freelance writer for the *Emerald*, was unavailable for comment.

The July 1991 speech in Albany, N.Y., attracted nationwide attention after Jeffries said Jews and the Mafia had conspired to belittle blacks in the movies and that Jews had helped finance the slave trade.

In October 1991, City University's trustees decided to allow Jeffries to serve a one-year term as black studies chairman but voted to replace him the following March. Each of the trustees found liable in the case had opposed extending Jeffries' chairmanship even for one year. The jury found they acted because of the speech.

During the trial, Jeffries' lawyer, Joseph Flemming, introduced evidence that showed school administrators found Jeffries was performing his job adequately despite the uproar over the speech.
