# Runners take third, sixth in meets

Oregon's cross country teams had mixed results at Saturday's Mountain West Classic in Montana.

The women placed three runners in the top 10 — including a fourth-place finish by freshman Milena Glusac — to finish third overall. The men were not as successful, as they failed to place a single runner in the top 20 and finished sixth as a team.

Glusac, running in her second race as a Duck, finished only 12 seconds behind winner Jennifer

Bravard, who ran unattached. Glusac was the second best collegiate runner behind Michigan's Molly McClimon.

Jenna Carlson ran one of her best races in an Oregon uniform, taking seventh overall and fifth among collegians. Niamh Zwagerman finished 10th for Oregon.

Michigan placed four runners in the top 12 to win the meet with 53 points. Brigham Young took second with 62, followed by Oregon with 78. The two other Pacific-10 Conference teams, Arizona and Washington State,

finished fifth and 15th, respectively.

Oregon's Melody Fairchild had a disappointing follow-up to last week's second-place finish in the Pier Park Invitational, placing 30th Saturday. Joni Wareham rounded out the Ducks' scoring, finishing 45th.

For the men, Oregon's top finisher was Karl Keska, who took 22nd. Even with a low top finisher, the most disappointing aspect of the meet was that the Ducks had only three runners in the top 50 — Keska, Tracy Hollister, who took 47th, and Rick Cantwell, who finished 49th.

The other scorers for Oregon were Scott Nicholas (55th) and John Dimoff (62nd).

Brigham Young won the men's team title, placing four runners in the top 25 to finish with 60 points, well ahead of second-place Virginia Tech (117). The Reebok Aggies took third with 142, followed by Michigan (146) and Idaho State (147).

On the positive side for Oregon, the Ducks managed to finish above Pac-10 foes Washington State and Arizona. The Cougars finished in seventh with 214, and the Wildcats took ninth with 243.

The Ducks will get into the heart of the season next weekend when the men will participate in the Willamette Invitational in Salem and the women will travel to Seattle for the Sun-dodger Invitational.


