Amazon demolition begins

Seven months of protests, delays and appeals were silenced last Thursday when two Amazon Family Housing buildings were demolished — marking the beginning of the end for the threatened complex.

University Housing Director Mike Eyster said the contractors will decide when more buildings will be demolished.

"We've given the contractors a lot of latitude and we wrote the contract that way to save money," Eyster said. "We've told them we need the site ready for construction this fall, but they don't have to announce specifically when demolition will

occur."

University officials have signed a \$370,000 contract with Delta, Sand and Gravel Construction Co. to begin preparations for clearing the south end of the complex by September.

The new Amazon complex is expected to be ready for occupancy by fall term 1996, with two-bedroom units renting for around \$400 a month.

Preparations are also underway by St. Vincent de Paul to move four of the buildings to a city-owned site at 200 E. 19th Ave., by May 15. The four buildings are being saved from demolition to renovate as low-income housing.

University and St. Vincent de Paul officials also are working

with the city of Eugene on plans to move more of the units that will be replaced during Phase II construction.

The Save Amazon Coalition was denied an injunction last Wednesday by a federal judge that would have prohibited St. Vincent de Paul's plans to move the four buildings.

Despite the ruling, supporters in favor of preserving the units are still going ahead with plans of their own to stop demolition.

Last Thursday, the coalition filed a request for a stay with the state Land Use Board of Appeals. If granted, the stay would require the University to stop all work at Amazon until the board could rule on the coalition's request.
