

## CHILOQUIN CHAMBER BOARD OF DIRECTORS MEETS, COMMITTEES ESTABLISHED



The board of directors of the Chiloquin Chamber of Commerce, elected at a general chamber meeting of Oct. 26, held its first meeting on November 2 at the Chiloquin City Hall. With President Dwight Kircher unable to be present, vice-president Dr. R. I. Kerwood presided. Following decisions to incorporate the Chamber as soon as possible and to set up the organization's bank account at the U. S. National Bank, committee appointments were taken up. The committees established reflected the needs originally recognized in forming the Chamber. A finance committee was set up designed to facilitate financing of homes, etc., in the community, either through establishing a bank or some other means. An industrial development committee was created to promote the establishment of new industries in the area and also to improve relations between the community and existing industries. A publicity-public relations committee was also organized, recognizing the need for increased publicizing of community activities and improved relations between Chiloquin and other areas. Other committees formed were the membership committee to promote the membership of the Chamber, a trade promotion committee to boost the retail and wholesale trading facilities of the community, and a budget committee, set up to maintain sound finances in the organization. Another meeting of the board was held Nov. 13, at Kircher's Hardware Store in Chiloquin. At this meeting an agenda was planned for the Nov. 16 general meeting. Committee functions and duties was regarded as the priority item for the general meeting, and these functions were outlined in writing. Other action taken included scheduling of the December general meeting, which was set for Dec. 7 at the Chiloquin Masonic Hall. This was to be a dinner meeting, starting at 7 P. M.

At the general meeting of Nov. 16, at Chiloquin High School, board progress in general was reported. Committee functions were explained to the general membership and a written outline of these functions was distributed. In regard to the committees, some discussion later occurred as to whether committee appointments should not be at least partly determined by the preferences of individual mem-

off-campus Catholic organization.

In high school she partook of a number of activities as well as maintaining an above-average scholastic record. She was on the annual staff in her junior and senior years. She served as student body secretary during her senior year, and was in CYO (Catholic Youth Organization), Sodality (a religious group), and Spanish Club. She studied Spanish 3 years at St. Mary's and hopes to continue it at S.O.C.

Concerning her post-graduate plans: "After I finish college I would like to join the Women Marines so I could see how other people live and see different parts of the country and yet get experience for my career. Then I'd like to come back and get a position as legal secretary."

Shirley regards termination as a "good thing for the Indians". BUT, "under the circumstances of the Klamaths I think we should have waited for awhile until we got used to the idea that we would be on our own, and also, learn how to budget our money and get enough education to get a good stable job." She cites, as sounding like a good idea, a suggestion she heard at an Indian Youth Conference in Provo, Utah, which she attended: "Hold off termination for awhile and gradually the Indian would want to terminate on his own."

As a remaining member, Shirley views trust management by the U. S. Nat'l Bank with confidence and does not expect to be confronted by any possible money management problems raised by termination: "I think the bank is doing a good job handling most Indians' money, because it is helping some of us keep our money a little longer, even though their fee is a little high for the money we are getting."

As to why she chose to remain in the tribe in the first place: "I thought there might be a chance of keeping some of the privileges we've had regarding hunting. When I chose I also thought I would be in a better position financially, although I thought there was a good chance either way."
