

## NOTICE OF DELINQUENT TAX LIST, 1912

This advertised list of delinquent taxes for the year 1912 for Columbia county, Oregon, is in pursuance of an act of the State Legislature which is embodied in chapter 361 of the General Laws of the 1911 session of the Legislative Assembly.

The taxes on the following advertised real property became delinquent on the 8th day of April, 1912, and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following described real property are delinquent, the Sheriff is authorized, upon demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and costs of advertising.

Certificates of delinquency shall bear interest at a rate not exceeding 15 per cent per annum from the date of issuance until the certificate is redeemed.
