HOG TESTS.

Three hog feeding tests were recently completed in Jackson County on three different farms. All hogs were on pasture and had access to all the grain they wanted through a self feeder. One of these lots made 100 lbs. of gain from 309 lbs. of ground wheat at a cost of .974 per pound. Kye pasture was used. Another lot fed ground barley, made 160 pounds of gain from 264 pounds of the grain. The cost per pound of gain was .677. Alfalfa pasture was used. The third lot was fed a grain mixture of corn, barley tankage and coconut meal. They gained 100 lbs. from 366 lbs. of the mixture at a cost of .836 cents per pound. In each case the pasture resulted in a big saving of grain. According to past records where grain alone was fed, it is safe to predict that the pasture in each of these tests, saved from 75 to 100 lbs. of grain in the production of each 100 lbs. of pork.

Robinson Crusoe's Musket.

The musket said to have been given to Alexander Selkirk when he was put ashore on the island of Juan Fernandez, 400 miles off the Chilean coast, has been going the rounds of British museums. It was Selkirk's adventures upon which was based DeFoe's famous story, "Robinson Crusoe." The musket is inscribed with the name of "A. Selkirk Largo, 1771." It was purchased by Randolph Berens, for \$6.25, but the owner has insured it for \$10,000.

Selkirk owned a tavern near Clapham, but died in 1723 at sea as a lieutenant aboard a naval vessel.

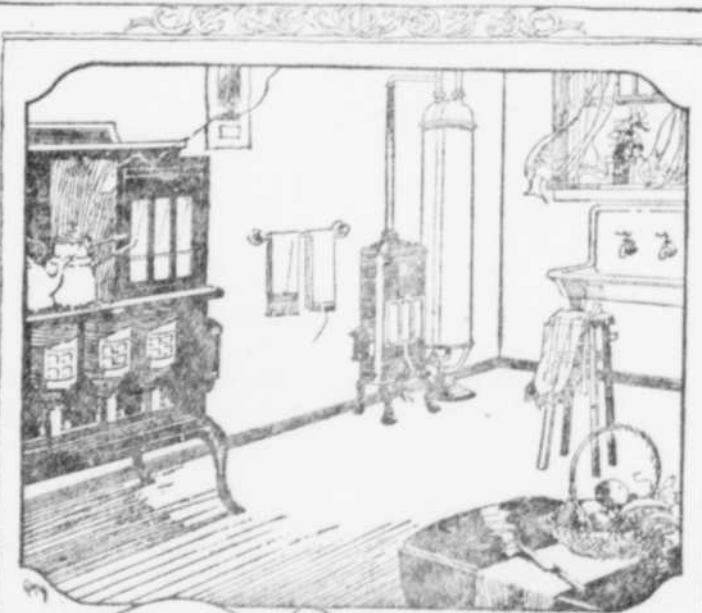
