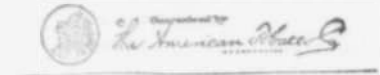

STATE WIDE HUMANE WORK

The Oregon State Humane society was one of the few organizations that received increased appropriations to carry on its work.

A new state law also requires teaching of kindness to animals in every public school of the state half an hour of each week.

Influential people have been placed on the board of trustees who will give the organization increased power and influence in its fight against cruelty to dumb animals and children.

The new members of the board include Manager W. S. Raker and Field Representative Elliot of the State Audubon society; Mrs. Millie Trumbull, head of the child labor and welfare work; W. A. Dickson, principal of one of the largest schools in Portland; County Superintendent of Schools Alderson.

Hon. Wm. Hanley of Burns, one of the biggest live at ek men in the state has become interested and will assist in extending the work of the humane education in eastern Oregon.

EXPERTS TO BUILD IDEAL SECTION

The Lincoln Highway Association has announced the names of the experts retained to collaborate in the final design of the Ideal Section which is soon to be built on the Lincoln highway, the funds being provided by the United States Rubber company.

The letting of the contract for the construction of the Ideal Section has been placed in the hands of Lockwood, Greene & Co., engineers, of Boston, Mass.

In charge of the final detailed design of the Ideal Section, will be W. G. Thompson, late state highway engineer of New Jersey, and formerly associated with General Goethals in the construction of the Panama Canal.

That the beautification of the Ideal Section may be of the same high standard as the construction work on the road itself, Jens Jensen, of Chicago, who is known as one of America's leading landscape architects, has been engaged.
